On the recommendation of the J&K Services Selection Board endorsed by the General Administration Department and in continuation of Government Order No. 160-PW(R&B) of 2023 dated 17.04.2023, sanction is hereby accorded to the appointment of Mohamad Abass Dar S/o Sh. Afroz Ahmad Dar (SL.S.No. 1315, Roll No. 201350314146, D.O.B. 05.03.2000, Domicile District Anantnag) under OM Category against the post of Multi Tasking Staff (MTS) in the Divisional Cadre Kashmir in respective category of nomenclature of the post to be allotted by the concerned Chief Engineer /HOD in the Pay Level of SL-1 (14800-47100) in the Public Works (R&B) Department.

Consequent upon his appointment, the appointee shall report to the office of the Chief Engineer, PW(R&B) Department, Kashmir within a period of twenty one (21) days from the date of issuance of this order. In case the appointee fails to join within the stipulated time period, his appointment shall be deemed to have been cancelled ab-initio without any notice.

The appointee shall be allowed to join on production of the following documents/certificates (in original) to be verified subsequently: -

- Academic/Qualification Certificate.
- 2. Matriculation/Date of Birth Certificate issued by the recognized Education Board.
- 3. Health certificate from the concerned Chief Medical Officer of the District.
- 4. Domicile Certificate from the competent Authority.
- 5. Valid relevant Category Certificate, if any applicable.
- 6. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

Sommer Services

The appointment of the candidate shall further be subject to the following conditions:-

- a) The appointee shall furnish an Undertaking in the shape of Affidavit to the effect that the appointee have no criminal records and also not facing any criminal proceedings in any Court of
- b) If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee for appointment as (Class-IV) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
- c) The salary of the appointee shall not be drawn and disbursed to her, unless satisfactory report in respect of genuineness of qualification / date of birth/relevant category certificate is received from the concerned authority.
- d) The appointment of the appointee shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- The appointee shall be on probation for a period of 92 years.
- f) The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department.
- g) The appointment shall be cancelled abinitio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
- h) The appointment of the above candidate shall be subject to outcome of any petition/(s), if any, pending before Competent Court of Law.
