The degree of the incumbent in Mechanical Engineering stands accepted by the department vide addendum No. PW(R&B)/NG/41/2010 dated 01.10.2013. the incumbent has been appointed on 19.10.1995 & the subsequent qualification has been passed by him on 19.03.2012. Accordingly, as per his appointment and qualification his name should figure in the seniority list at Serial No 09.
