Sanction is hereby accorded to the release and advance drawal of funds by the Director Finance PW(R&B) Department to the tune of Rs. 95,31,46,000/- (Rupees Ninety five crores thirty one lakhs forty six thousand only) received from MoRD Govt. of India as grant-in-aid to the UT of J&K under PMGSY as Central assistance, released by the Finance Department vide U.O No.56438-FD-RESOCSS/16/2021-03-FD/438 dated.18.02.2022 for its crediting into Programme fund Account of JKRRDA.

The funds so authorized are subject to the following conditions: -

- Funds are to be used on for the purpose for which these are released.
 - Director Finance of the Department shall vouchsafe the availability of funds under relevant head of account.
 - All codal formalities are fulfilled.
 - Advance payment if any be made, shall be adequately secured and properly guaranteed before the release of actual payment.
 - The Technical sanction/administrative approval shall be obtained prior for undertaking the said work from the competent authority.
 - The expenditure shall be incurred strictly as per the guidelines of the scheme and conditions laid down in the sanctioned letter of the concerned Ministry, Govt. of India
