- 1. Quotations must be endorsed in properly superscribed envelopes.
- 2. The rate unit must not under any circumstances be altered and the rates must be entered in words as well as in figures. Additions/alterations, if any, must be properly initiated and cell taped.
 - a). Envelope 1st: Specifications, Income Tax Clearance certificate, PAN Card, VAT clearance, TIN No. Information.
 - b). Envelope 2nd: Financial Bids.
- 3. Tenders should be given by the registered firms only indicating C.S.T and G.S.T. Nos. Copies of which should be enclosed with the tender alongwith a certificate from Sales Tax/IT Department to the effect that the tenderer has filled the Sales tax/IT return of last Quarter.
- 4. The tenderer shall be deemed to have carefully examined the conditions, specifications, size make etc. of the Magazine to be printed and supplied in a quality manner. If he shall have any doubt as to the meaning of any portion of these conditions or of the specifications, size, make patent etc, he shall before filling the tender, refer the same to the Financial Advisor/CAO of PW(R&B), Department, Civil Secretariat, J&K.

The Commissioner/ Secretary to Government, PW(R&B), Department, Civil Secretariat, J&K or his duly authorized representative shall have at all reasonable time access to the suppliers premises and shall have the power at all reasonable times to inspect and examine the materials and workmanship of the Magazine to be printed/ supplied.
 - 7. The rates quoted must be F.O.R destinations in the premises of PW(R&B), Department, Civil Secretariat, J&K and shall include all charges/expenses/ Taxes/ freight etc. The tenderer shall be responsible for the proper packing so as to avoid any damages during the transportation and delivery of the Magazine in good conditions. No extra cost on such account shall be admissible.

The tenderer whose tender is accepted shall arrange supplies of 10,000 copies of Printed Magazine within a period of three days as per approved samples of Magazine of the Department from the date of receipt of supply order according to the requirement of the department. In case it fails to supply the same, the department reserves the right to blacklist the firm and forfeit its CDR.
 - 9. The contract of supply can be repudiated at any time if the supplies are not made to the satisfaction of Commissioner/ Secretary to Government, PW(R&B), Department, Civil Secretariat, J&K.
 - 10. Tender must be filled in ink or ballpoint pen. Tenders filled in by pencil or otherwise shall be rejected, additions and alterations in the tender should be avoided. No over writing should be done. Corrections in the rates, if any, should be done clearly and properly initiated.

- 11. The tenderer should sign the tender form and document at each page at the end in token of the acceptance of all the terms and conditions of the tender and the agreement.
- 12. The tender must be accompanied by an earnest money as stipulated in the tender Notice without which tender will be rejected. The amount of earnest money must be deposited in the shape of cash deposit receipt/FDR of any scheduled bank duly pledged to the Commissioner/ Secretary to Government, PW(R&B), Department, Civil Secretariat, J&K. The earnest money will be refunded to un-successful tenderer within one month of the final acceptance of the tender whereas in case of successful tenderer it will be retained and treated as security till the execution of the contract in full. No interest will be paid by the department on this amount.
- 13. The successful tenderer will have to enter into agreement with the Commissioner/ Secretary to Government, PW(R&B), Department, Civil Secretariat, J&K, within three days from the communication of the acceptance of the tender on non-judicial paper of Rs. 100/- only.
- 14. Advance payment will not be made under any circumstances.
