Whereas, the Chief Engineer, MED, Jammu vide his letter No. CEM/J/ 4706-07 dated 22.03.2019 has forwarded the case of Sh. Vipan Parihar, Draftsman (Mechanical), Mechanical Division, Khellani, Doda alongwith allied documents for accepting of his three years diploma (Mech) and inclusion of his name in the seniority list of Diploma Holders Draftsman (Mechanical) as per following particulars:-

Whereas, the Chief Engineer, MED Jammu has stated that Sh. Vipan Parihar, Draftsman (Mechanical) MED Khellani has been appointed as Draftsman (Mechanical) vide Government Order No. 57-PW(R&B) of 2017 dated 06.02.2017 on the basis of certificate of 2 years Draftsmanship and he has passed 3 years diploma in Mechanical Engineering as per certificate issued by J&K Sate Board of Technical Education prior to his appointment in Government service.

Whereas, the case was examined in this department and marks/ diploma certificates of the above named official were forwarded to the Secretary, J&K State Board of Technical Education on 18.01.2021 for verification/ authentication & genuineness of the diploma/ marks certificates. In response, the Secretary, BOTE, J&K Jammu vide letter No. BOTE Poly/ Verif/ 305/ 21/ 289 dated 25.01.2021 has intimated that diploma/ marks certificates of the candidate has been verified with the record and authenticated that the candidate has passed 03 year Diploma in Mechanical Engineering.

Whereas, the above named incumbent has also produced undertakings in the shape of Affidavit dully attested by the 1st Class Magistrate affirming therein that "in case any information about his Diploma (Mechanical) is found fraudulent/bogus at any time during service, the same shall be deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against him in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956".

Whereas, the case was again examined in the department and a notice was issued vide No. PW (R&B)/ HRM/ 3/ 2021-D dated 15.02.2021 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer Mechanical Engineering Department Jammu vide his letter No. CEM/J/4630 dated 18.10.2021 has intimated that no objection has been received by his office from the subordinate offices against the notice issued by the Administrative Department regarding acceptance of diploma acquired by Sh. Vipin Parihar, Draftsman (Mechanical).

Whereas, the case has been re-examined in the department and it has been decided to accept the Diploma certificates acquired by the above named official, treat him as Diploma holder Draftsman (Mechanical) and include his name at appropriate place in the relevant seniority list of Diploma holders Draftsman (Mechanical) and also exclusion of his name from the relevant seniority list wherever exists.

Now therefore, Mr. Vipin Parihar, Draftsman (Mechanical) shall henceforth be treated as Diploma holder Draftsman (Mechanical) and subsequently his name shall be included at appropriate place in the relevant seniority list of Diploma holders Draftsman (Mechanical) as and when the same is notified afresh, consequently his name shall be deemed
