Further, the reserved category/selection category recorded against some members, shall not be taken as final at the time of consideration for placement/promotion to higher posts and shall be subject to production of genuine/valid reserved category certificates at the relevant point of time, issued by the competent authority.

The seniority shall be subject to the outcome of writ petition(s), if any, pending adjudication before any Hon'ble Court of Law.
