The Executive Engineer concerned shall operate the funds placed at their disposal under Major Heads; 2059-Public Works, 3054-Roads & Bridges, 2071-P&ORB, 2055-Police, 5054-Capital (Outlay), 4059-COOPW, 8009-GP Fund, 8011-SLI, 8443- Civil Deposits & remittance thereof.

The DDO Powers are subject to the fulfillment of following conditions:

- a) That he shall operate on the treasury to the extent funds are placed at his disposal by the competent authority.
- b) That all the codal formalities should be fulfilled while incurring the expenditure.
- c) That no excess over allotment/irregular expenditure is made by the DDO.
- d) That the concerned DDO shall ensure submission of the Accounts to the different quarter in time.
- e) That the DDO shall submit the monthly Receipt/Expenditure statement to the Administrative Department through their controlling Office.
