Subject: Acceptance of Degree of Er.Rajinder Singh, Junior Engineer (Mechanical) and inclusion of his name in the seniority list of Degree Holders Junior Engineers (Mechanical) in PW(R&B) Department.

Whereas, as per provisions of J&K Engineering (Subordinate) Service Recruitment Rules, 1997, a Junior Engineer, Diploma holder after acquiring Degree in relevant branch of Engineering is to be treated as Degree holder for the purpose of seniority from the date of completion/ passing of Degree; and

Whereas, the department has received the case of Er.Rajinder Singh, Junior Engineer (Mechanical) whose particulars are given below for acceptance of his Degree and inclusion of his name in the seniority list of Degree Holders Junior Engineers (Mechanical):-

Whereas, the case was examined in the department and Degree/ Marks certificates of the incumbent were forwarded to the concerned University/ Institution vide letter dated 16.12.2014 for verification of genuineness of the Degree acquired by the said Junior Engineer. In response the concerned University/ Institution vide their communication No.JK-13695/31/15 dated 06.01.2015 has verified the degree certificate of the incumbent.

Whereas, the above named incumbent has also produced undertakings in the shape of Affidavit dully attested by the 1st Class Magistrate affirming therein that in case any information about his degree/ certificate is found bogus at any time in his service, his degree shall deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against in light of J&K Civil Service Services Classification Control & Appeal Rules, 1956.

Whereas, on further examining of the case, it has been observed that there is a case to accept his Degree from the date of passing and include his name at appropriate place in the relevant seniority list of Degree Holders Junior Engineers (Mechanical) as and when the same is notified afresh and also exclusion of his name from the seniority list of Junior Engineers Diploma holders (Mechanical);

Whereas, the case was further examined in the department and a notice was issued on



24.01.2022 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer MED Jammu vide his letter No. CEM/J/7685 dated 24.03.2022 has intimated that the said notice was published in the newspapers, however, till date no objection has been received by them regarding the proposed action.

Whereas, the Finance Department has issued circular instructions under endorsement No.A/HACM (2012)-PMO-49 dated 01.02.2019 clarifying therein that the advance increments to degree holders on their appointment as Junior Engineers are available on initial appointment and not at the time of acquiring degree after entry into Government Service as Diploma holder.

Now, therefore, Er. Rajinder Singh, Junior Engineer (Mechanical), (Diploma holder) shall henceforth be treated as Junior Engineer (Mechanical) Degree holder and his name shall be included at appropriate place in the seniority list of Degree Holders Junior Engineers (Mechanical) as and when the same is notified afresh, besides, his name shall be deemed to be excluded from the seniority list of Junior Engineers (Mechanical) Diploma holders. However, the pay of the Engineer shall be regulated as per circular instructions issue by the Finance Department under endorsement

No.A/HACM (2012)-PMO-49 dated 01.02.2019.
