- ii. The funds shall be utilized after following all the required formalities as envisaged in GFR-17 read with SDRF guidelines/forms and decision taken in the matter during SEC while going for procurement of items for snow clearance.
- iii. That CE MED Kashmir shall furnish red DC Account to the concerned within stipulated time period.
- iv. That all coda formalities in consonance with GFR shall be fulfilled before incurring the expenditure.
- v. The expenditure shall be closely monitored and incurred only such items which are approved under the scheme
