Whereas, the J&K Services Selection Board vide advertisement Notification No. 02 of 2014 dated 30.12.2014 invited applications from eligible candidates for the post of Junior Engineer (Civil) State Cadre, under Item No. 134; and

Whereas, the candidate namely Zaffar Iqbal S/o Mohammad Iqbal R/o Thangdumbar, Sankoo Kargil stand selected under ST category among other three (03) ST category candidates to the post of Junior Engineer (Civil) by the JKSSB in compliance to the judgement of the Hon'ble High Court passed in SWP No 976/2016 clubbed with SWP No 1218/2016 dated 08-11-2017; and

Whereas, in compliance to the Hon'ble High Court directions / order dated 25.08.2021 passed in LPASW No. 225/2017,IA No. 1/2017 & 1/2018 CM No. 2297/2019 c/w PERLP No 28/2017 titled Archana Baloria and another V/s State of J&K and others, the department issued appointment order in respect of three (03) ST category selected candidates having domicile of UT J&K vide Government order No. 364-PW(R&B) of 2021 dated 09.12.2021; and

Whereas, with regard to appointment order in favour of one candidate namely Zaffar Iqbal S/o Mohammad Iqbal R/o Thang Dumbhar, Sankoo Kargil, the matter was referred to the General Administration Department seeking advice in concern with the apportionment of posts with the Union Territory of Ladakh, before issuing formal appointment order in favour of the said candidate; and

Whereas, in turn, the General Administration Department vide O.M. No. GAD-MTG0RBIV/200/2021-09-GAD dated 22.03.2022 has conveyed the approval of the Administrative Council passed in Decision No. 47/3/2022 dated 15.3.2022 to the

proposal for issuance of appointment order in respect of the one post of Jr. Engineer (Civil) which was referred to the recruiting agencies prior to 31.10.2019 vide No. PW(R&B)/NG/145/2010 dated 26.12.2014 and the recommendation received from the concerned recruiting agency vide Order No. 738-SSB of 2017 dated 06.12.2017 issued vide endorsement No. SSB/Secy/Sel/2017/12880-93 dated 06.12.2017 on the terms and conditions as mentioned below:-

- 1. The post(s) against which order(s) are to be issued should be free from all encumbrances.
- 2. There are no Court interventions/orders etc.
- 3. All other terms and conditions for issuance of appointment orders issued by Government from time to time shall be followed.
- 4. If any of the above select lists/recommendations have lost validity owing to delay in issuance of appointment orders/other procedural delays, one time relation is also granted with the directions to concerned Department to issue appointment orders within a period of one month from the date of issuance of the said O.M i.e. from 22.03.2022.

Whereas, the Criminal Investigation Department, Jammu and Kashmir vide No. CID/VB/2021/FINAL/39185-187/OD dated 13.11.2021 has furnished the final verification report with an intimation that as per index check/report of field agencies there is nothing adverse against Mr. Zaffar Iqbal S/o Mohd Iqbal R/o Thang Dumbhar Sankoo Kargil District Kargil.

Now, therefore, in light of Administrative Council Decision No. 47/3/2022 dated 15.3.2022 and consequent upon the recommendation of the J&K Service Selection Board and in compliance of directions of the Hon'ble High Court, J&K and Ladakh, Jammu dated 25.08.2021 passed in LPASW No. 225/2017, IA No. 1/2017 & I/2018 CM No. 2297/2019 C/W PERLP No. 28/2017 titled Archana Baloria and another V/s State of J&K and others, sanction is hereby accorded to the appointment of Zaffar Iqbal S/o Mohd Iqbal R/o Thang Dumbhar Sankoo, Kargil as Junior Engineer (Civil) in the Pay Level 6 (35400-112400) notionally with effect from 25.05.2016 and monetarily with immediate effect.

- The appointee shall report to the office of the Chief Engineer, PW(R&B) Department Kashmir within a period of 21 days from the date of issuance of this order and if the candidate fails to join within the stipulated time, he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.
- The candidate shall be allowed to join only on the production in original and verification of the following certificates/documents:-
  - Educational/Technical Qualification certificate/marks sheet which will also include whether technical degree/diploma is approved for government employment in J&K.



2. Date of Birth certificate/Matriculation certificate.

3. Permanent Resident Certificate/Domicile Certificate.

- 4. Age and Health certificate issued by an officer not below the rank of Chief Medical officer.
- 5. Certificate from concerned authorities to the effect that no loan under Self Employment Scheme has been obtained/availed by the concerned candidate.
- 6. Reserved category certificate, wherever applicable.
- 7. Any other relevant certificate as required under rules.

Further, the appointment shall be provisional and subject to the following conditions:-

- a. The appointee shall furnish an Undertaking in the shape of an Affidavit to the effect that the appointee have no criminal records and also not facing any criminal proceedings in any Court of Law; and
- b. If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee for appointment as (Jr. Engineer ) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her; and
- c. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate / Technical Qualification is received from the concerned Authorities/Agency; and
- d. The appointment of the candidate shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, pay and Allowances) and Fixation of Tenure Rule, 2020 notified vide S.O. 192 of 2020 dated 17 th June, 2020; and
- The inter-se-seniority of the appointee shall be drawn in accordance with the merit secured by the appointee in the selection list prepared by the J&K Services Selection Board; and
- f. The other terms and conditions shall remain same as laid down in the Government order No. 173-PW(R&B) of 2016 dated 25.05.2016; and
- g. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before Competent Court of Law.
