

 - vi. Valid relevant Category Certificate, if any applicable.
- c) The appointment of the aforesaid candidates shall further be subject to the following conditions:
 - a. The appointee(s) shall furnish an Undertaking in the shape of Affidavit to the effect that the appointee have no criminal records and also not facing any criminal proceedings in any Court of Law.
 - b. If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee for appointment as (Class-IV) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.

 - d. The appointment of the appointee (s) shall be governed in terms of Jammu and Kashmir Probationer (Condition of Service, pay and Allowances) and Fixation of Tenure Rule,2020 notified vide S.O. 192 of 2020 dated 17.6.2020.
 - e. The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department.
 - f. The appointment shall be cancelled abinitio, if it is found that the candidates are having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
