Whereas, as per the application of the official, he was working in the office of Assistant Executive Engineer, Mechanical Tube Well Sub Division Srinagar; and

Whereas, the Chief Engineer, I&FC Department Kashmir vide his letter No. 16967-69 dated 20.3.2019 forwarded the representation of Mr. Moin UI Islam Ahanger S/o Mohd Abdullah Ahanger R/o Turkwangam Shopian alongwith the application form for the post of Assistant Director Fire & Emergency advertised by J&K Public Service Commission vide Notification No. 12-PSC (DR-P)/2017 dated 27.11.2017 as in-service candidate for onward submission to the J&K Public Service Commission; and

Whereas, vide this department's letter NO. PW(M&S)/30/2019 dated 22.3.2019, the application form of the official was forwarded through proper channel to the Secretary J&K Public Service Commission, Jammu for further necessary action; and

Whereas, the Junior Engineer has tendered technical resignation through the medium of representation dated 27.03.2021 before the Assistant Executive Engineer, Mechanical Tube Well Sub Division Srinagar stated therein that vide Government order No. 71-Home of 2021 dated 25.3.2021 issued by the Home Department in pursuance to the Notification No. 02-PSC(DR-S) of 2021 dated 04.1.2021 of J&K Public Service Commission, he has been appointed as Assistant Director, Fire & Emergency Services under RBA Category; and

Whereas, the Chief Engineer Mechanical Engineering Department Kashmir vide his letter No. MED/K/Adm/06-07 dated 02.4.2021 has recommended the technical resignation tendered by Shri Moin Ul Islam Ahanger, Junior Engineer with effect from 27.03.2021; and
