Whereas, promotion of Junior Engineers (Civil) as I/C Assistant Engineers (Civil) who were appointed under PM's Special Package for Rehabilitation of Kashmiri Migrants has not been considered at this stage as these posts were created on supernumerary basis by Relief & Rehabilitation Department and don't form part of sanctioned Cadre strength of JEs of R&B Department notified vide Government Order No.303-PWD(R&B) of 2013 dated 05.09.2013 read with SRO 661 & 662 of 2019 dated 25.10.2019. The General Administration Department has constituted a Committee vide Govt Order No.292-JK(GAD) of 2021 dated 31.03.2021 to resolve the issue regarding their seniority and other promotion prospects, as such their case shall be considered on merits as and when the decision on the issue is taken by the Committee constituted for the purpose.



Whereas, issue relating to the placement of Junior Engineers (Civil) as I/c Assistant Engineers who have obtained their degrees from the Institutions other then AMIE Kolkata i.e IGNOU and AMICE, Ludhiana was taken up with the AICTE by the department vide letter No.PW(R&B)/ Legal/135/2019 dated 04.12.2020, in response to which the AICTE vide their communication No.NWRO/AICTE/ Verification/ 2020-21 dated 17.03.2021, among others, has clarified as under:-

1.	IGNOU	IGNOU does not come under the purview of AICTE. However, AICTE has issued a circular AICTE/P&AP/ IGNOU/ misc/ 2020 dated 25.11.2020 which is as per the approval of EC/ Council in the basis of Supreme Court judgement.
5.	The Institute of Civil Engineering (India) Ludhiana	The Institute of Civil Engineering (India) Ludhiana are Professional Bodies conducting technical courses and awarding associate membership to the candidates who qualify the examination conducted by them. In this regard, AICTE has issued a circular F.No.13-56/ PC/ ODL-Mode/ AICTE/ 2020 recognition of certification awarded by Professional Bodies/ Institutions dated 23.11.2020 which is self explanatory. The professional societies recognized by MHRD upto 31.05.2013 were permitted to conduct section A&B exams and treated equivalent to degree upto 31.05.2013 only.

Whereas, the placement order in respect of 26 Engineers (13-Degree & 13-Diploma) is kept on hold as they have failed to submit their requisite documents/ vigilance clearance. All such Engineers are directed to complete requisite formalities within a period of 30 days, failing which it shall be presumed that they are not interested for further placement and the posts/ slots shall be utilized for the placement of next eligible Engineer in order of seniority in the respective category and their candidature/ claim shall be considered in subsequent accruals of the vacancies. Moreover, Six (06) posts from Diploma holder's quota are kept reserved for candidates having superior claim, if any.

Now, therefore, sanction is hereby accorded to the placement of following Junior Engineers (Civil) (Degree/ Diploma) as I/C Assistant Engineers (Civil) in their own pay and grade for a period of six months or till regular promotion/ confirmation by the J&K PSC/ DPC whichever is earlier:-
