In terms of U.O No.A/56 (2013) -414 dated 26.04.2020 issued by Finance Department, ex post-facto sanction is hereby accorded to the reimbursement of medical expenses incurred on treatment of late Sabiya Rajab Ex- Junior Engineer, PW (R&B) Division, Budgam, in favour of her legal heirs, at Medanta-The Medicity, Gurgaon, Hospital, New Delhi in relaxation of Rule 6-A of the J&K Civil Services (Medical Attendance-Cum-Allowance) Rules 1990, subject to the following conditions:-

- i. Reimbursement of charges shall be restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof shall be restricted to the extent of rates applicable to such items/procedures at AIIMS, New Delhi.
- ii. All relevant medical bills/vouchers shall be verified from relevant medical authority of the hospital wherefrom treatment has been taken.
- iii. Essentiality Certificate on Form 2 issued by the Hospital authorities is obtained ad kept on records.
- iv. Certificate from the competent medical authority (Director Health services/Principal GMC/other) is obtained to certify that drugs and services charged are reasonable and to establish genuineness of the treatment availed in the said hospital.
- v. Follows up(s), if any are regulated under rules.
