Whereas, the Chief Engineer, MED, Jammu vide his letter No. CEM/J/6519 dated 14.01.2022 has forwarded the case of Sh. Ramesh Lal, Foreman Grade-I whose particulars are given below for accepting of his diploma and inclusion of his name in the relevant seniority list:-

Whereas, the case was examined in this department and diploma/ marks certificates of the above named official were forwarded to the Controller of Examination, Institution of Mechanical Engineers, vide this department's letter dated 04.02.2022 for verification/authentication of genuineness of the diploma/ marks certificates acquired by the official. In response, the Member of the Council (Institution of Mechanical Engineers (India) vide letter No. BJK-19403/31/2022 dated 25.02.2022 has verified that:-"Shri Ramesh lal bearing Membership No. 97598 has obtained final pass in Part-II of the Technician Engineers Examination in June 2015 with Roll No. PII-0400430. Further the Final Pass Certificate is genuine, duly issued by this office to Shri. Ramesh Lal".

Whereas, the above named incumbent has also produced undertakings in the shape of Affidavit dully attested by the Executive Magistrate 1st class Jammu affirming therein that:-"the contents of the affidavit are true and correct to the best of his knowledge and belief, if proved false, he shall be personally responsible for the same"



Whereas, on examining the case, it has been observed to accept the Diploma certificates acquired by the above named official from the date of passing and include his name at appropriate place in the relevant seniority list of Diploma holders Foreman (Mechanical) and also exclusion of his name from the relevant seniority list wherever exists.

Whereas, the case was further examined in the department and a notice was issued vide No. PWD-HRM1/11/2022-05-PWD-R&B Deptt dated 15.03.2022 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer Mechanical Engineering Department Jammu vide his letter No. CEM/J/354 dated 20.04.2022 has intimated that his office has not received any objection from any member of the cadre against the notice issued by Administrative Department regarding acceptance of Diploma acquired by Sh. Ramesh Lal Foreman Grade-I".

Now therefore, Mr. Ramesh lal Foreman Grade-I shall henceforth be treated as Diploma holder Foreman Grade-I (Mechanical) from the date of passing diploma and subsequently his name shall be included at appropriate place in the relevant seniority list of Foreman (Mech) Diploma holders as and when the same is notified afresh, consequently his name shall be deemed to be delete from the seniority list wherever exists.
