Subject:- Cancellation of placement order of I/c Executive Engineer (Mechanical).

Government Order No : 183 - PW(R&B) of 2021
Dated: 20.05.2021

Whereas, vide Government Order No. 167-PW(R&B) of 2021 dated: 30.04.2021, Er. Jasbir Singh, I/c Assistant Executive Engineer (Mechanical) (degree holder) and Er. Mohammad Maqbool Dar, I/c Assistant Executive Engineer (Mechanical) (diploma holder) among other 14 I/c AEEs were placed as I/c Executive Engineer (Mechanical) in their own pay and grade subject to the following conditions:-

- i. That they shall not be having any preferential right for promotion at the time of their regularization/ confirmation through DPC/ PSC.
- ii. The outcome of writ petition(s) pending, if any, before any competent court(s) of law.
- iii. Since, the proposal was being made in view of COVID emergency and the department was having meagre time to collect the requisite documents from concerned quarters, so the engineers were given 30 days time for submission of the requisite documents viz APRs/Vigilance Clearance, Integrity Certificates etc and in case of non receipt of the requisite documents within stipulated time or any adverse report to be received from any agency/HOD against any engineer(s), his/her placement order shall be deemed to have been cancelled ab-initio.

Whereas, the department came to know through a writ petition titled Tasaduq Hussain Dar Vs UT of J&K & Ors that the

recently placed I/c Executive Engineers (Mechanical), namely Mr. Jasbir Singh (degree holder) and Mr. Mohammad Maqbool Dar (diploma holder) are involved in the case FIR No. 23/2015 U/S 5(1) (d) r/w 5(2) P C Act. Svt. 2006 U/S 120-B RPC and case FIR No. 19/2000 P/S VOK respectively and the same was found exact from the records.

Therefore, in view of the above, the placement order in respect of Mr. Jasbir Singh (degree holder) and Mr. Mohammad Maqbool Dar (diploma holder) to the next higher scale i.e. I/c Executive Engineer issued vide Government Order No. 167-PW(R&B) of 2021 dated: 30.04.2021 is hereby revoked ab-initio.

The above engineers shall report to their concerned Chief Engineer, Mechanical Engineering Department immediately till further orders.
