**Now, therefore**, Er.Tejinder Singh Soodan, the then I/c Executive Engineer, Division Hospital(GMC &AH) Mechanical Engineering Department, Jammu is hereby reinstated and his period of suspension (i.e., 23.09.2020 to 20.05.2021) is treated as on duty. Besides, he is posted as Technical Officer to Chief Engineer, Mechanical Engineering Department, Jammu till his retirement i.e. on 31.05.2021.
