Whereas, the Accelerated Recruitment Committee (ARC) forwarded 1450 vacancies of Class-IV (now MTS) pertaining to the Public Works (R&B) Department to the General Administration Department for further referral to the Jammu and Kashmir Services Selection Board under Rule 4 of the Jammu and Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020; and

Whereas, the General Administration Department vide indent No. GAD/MTG/RB- IV/50/2020-I dated 22.06.2020, referred 8575 Class-IV posts of various Departments including 1450 posts pertaining to the Public Works (R&B) Department viz (75 posts of UT and 1375 of Divisional Cadre) to the J&K Services Selection Board for making selection of suitable candidates under the provisions of Jammu and Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020 notified vide S.O. 184 of 2020 dated 04,05,2020; and

Whereas, the J&K Services Selection Board vide their letter No. SSB/Secy/Sel/Class- IV/2021/7103-11 dated 18.10.2021, recommended the selection list of 5115 candidates and 60 posts kept withheld against these Class-IV indented posts of various cadres to the General Administration Department for further necessary action; and

Whereas, the General Administration Department in the first phase of selection recommended 622 candidates to the Public Works (R&B) Department out of 1450 vacancies for issuing appointment orders with the terms and conditions as already issued from time to time by the Government including the conditions as mentioned vide O.M. No. GAD/MTG0RBIV/63/2021-09-GAD dated 19.10.2021; and

Whereas, the Public Works (R&B) Department issued appointment orders in respect of those candidates whose positive CID Verification reports had been received from the respective District Magistrates; and

Whereas, among others, the candidate namely Rubeena Farooq D/o Farooq Ahmad Rather R/o Arahama Kangan Ganderbal stand also selected for the post of MTS in the Public Works (R&B) Department bearing Deptt. 5.No. 446, SL No. 154, Roll No. 231411343508 in the first phase of selection issued by the J&K Services Selection Board vide No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021, however, her CID report remained awaited from the concerned issuing authority; and

Whereas, the District Magistrate Ganderbal vide No. DCG/CID/VER/2022/2036 dated 03.01.2023 duly endorsed by the Criminal Investigation Department vide Final No. CID/VB/2022/FINAL/9079-9103/GBL-21 dated 21.12.2022 furnished the Character & Antecedents verification report of the said candidate namely Ms. Rubeena Faroog D/o Faroog Ahmad Rather with an intimation that as per index check/reports of field agencies, there is nothing adverse against the said individual; and

Whereas, as per sub-rule (5) of Rule 14 of the Jammu and Kashmir Civil Services Decentralization Recruitment Rules, 2010, the select list shall remain in force for a period of one year from the date the select list is sent

to the requisitioning authority; and

Whereas, the validity period of selection list issued by the J&K Services Selection Board vide No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 was till 17.10.2022 in terms of Decentralization Act, 2010; and

Whereas, the matter was referred to the General Administration Department vide O.M. No. PWD-NGAZ0CIV/341/2022-05 (7080047) dated 10.01.2023 for re- validation of selection list in favour of Ms. Rubeena Farooq, whose positive Character & Antecedents verification report has been received from the District Department Criminal Investigation endorsed the by duly Magistrate Ganderbal belatedly; and

Whereas, in turn, the General Administration Department vide U.O. No. GAD-MTG0RBIV/16/2023-09-GAD dated 20.02.2023 opined as under:-

"The Department is advised to submit a Coordination Proposal/Note for seeking extension in the validity of select list in favour of Ms. Rubeena Farooq D/o Farooq Ahmad Rather R/o Arahama Kangan Ganderbal (RBA), selected as Class-IV (MTS) by the Services Selection Board in relaxation of sub-rule (5) of Rule 14 of the Jammu and Kashmir Civil Services Decentralization and Recruitment Rules, 2010*.

Whereas, in light of the advise of the General Administration Department, a Coordination proposal was submitted for consideration/approval of the Hon'ble Lieutenant Governor through Chief Secretary with the following resolution :-

Sanction is hereby accorded to the extension in the validity of select list of Class-IV in faovur of Rubeena Farooq D/o Farooq Ahmad Rather R/o Arahama Kangan Ganderbal , selected as Class-IV (MTS) by the J&K Services Selection Board in the Public Works (R&B) Department under Deptt. S.No. 446, SLNo. 154, Roll No. 231411343508 in relaxation of sub-rule (5) of Rule 14 of the J&K Civil Services(Decentralization) Rules, 2010.

Whereas, the General Administration Department vide U.O. No. GAD- CORD/54/2023-09 dated 24.04.2023 has conveyed the approval of the competent Authority (Hon'ble Lieutenant Governor) to the Departmental proposal regarding "extension in validity period of select list of Class IV (MTS) in favour of the selected candidate namely Rubeerta Farooq", in whose favour character antecedents report had been furnished by the Criminal Investigation Department belatedly after expiry of validity period of the select list as under:-

*In relaxation of Rule 14 (5) of the J&K CivilServices(Decentralization) Rules, 2010, sanction is hereby accorded to the extension of the validity of select list for the post of Class-IV(MTS) in favour of Ms.Rubeena Farooq D/o Farooq Ahmad Rather R/oArahama Kangan, Ganderbal in P u b 1 i c Works (R&B) Departmentrecommended by the J&K Services Selection Board vide No.SSB/Secy/Sel/Class-IV/2021/7103-11 Dated 18-10-2021 beyond the date of its expiry i.e, 17-10-2022 upto 30-05-2023".

Now, therefore, on the recommendation of the J&K Services Selection Board endorsed by the General Administration Department and in continuation of Government Order No. 185-PW(R&B) of 2023 dated 08.05.2023, sanction is hereby accorded to the appointment of Rubeena Farooq D/o Farooq Ahmad Rather R/o Arahama Kangan Ganderbal (Deptt. S.No. 446, SL. No. 154, Roll No. 231411343508 Domicile District-Ganderbal) against the post of Multi Tasking Staff (MTS) in the Divisional Cadre Kashmir under RBA category in respective category of nomenclature of the post to be allotted by the concerned Chief Engineer/HOD in the Pay Level of SL-1 (14800-47100) in the Public Works (R&B) Department.

Consequent upon her appointment, the appointee shall report to the office of the Chief Engineer, PW(R&B) Department, Kashmir within a period of twenty one (21) days from the date of issuance of this order. In case the candidate fails to join within the stipulated time period, her appointment shall be deemed to have been cancelled ab-initio without any notice.

The appointee shall be allowed to join on production of the following documents/certificates (in original) to be verified subsequently: -

Academic/Qualification Certificate.

Matriculation/Date of Birth Certificate issued by the recognized Education Board.

Health certificate from the concerned Chief Medical Officer of the District.

Domicile Certificate from the competent Authority.

Valid relevant Category Certificate, if any applicable.

That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from his/her salary, DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

The appointment of the candidate shall further be subject to the following conditions:-

a. The appointee shall furnish an Undertaking in the shape of Affidavit to the effect that the appointee have no

criminal records and also not facing any criminal proceedings in any Court of Law.

 The clearance received from the District Magistrate, Ganderbal is provisional and it shall be mandatory for the appointee to fill in the verification rolls (V-Rolls), as available through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee, or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment ab-initio, without any further notice.

c. If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee for appointment as (Class-IV) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be

initiated against his/her.

d. The salary of the appointee shall not be drawn and disbursed to her, unless satisfactory report in respect of genuineness of qualification / date of birth/relevant category certificate is received from the concerned

e. The appointment of the appointee shall be governed by the "New Pension Scheme" as per SRO-400 of 2009

dated 24.12.2009.

The appointee shall be on probation for a period of 02 years.

g. The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department.

 The appointment shall be cancelled abinitio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.

The appointment of the above candidate shall be subject to outcome of any petition/(s), if any, pending before Competent Court of Law.
