Whereas, Shri Rajesh Roshan Raina S/o Late Shri Roshan lal Raina R/o Tral Payeen Tehsil Tral District Pulwama, Kashmir was appointed as Junior Assistant in Public Works (R&B) Department Kashmir (Divisional Cadre) vide order No. K-60(Estab) of 2016 dated 10.6.2016 and posted to (R&B) Division Pulwama on the basis of recommendation of Service Selection Board forwarded vide letter No. SSB/Secy/Sel/71/2014/5789-90 dated 19.6.2015 duly endorsed by the Relief & Rehabilitation Department vide O.M. No. Rev/MR/57/2011-I dated 31.7.2015; and

Whereas, the Chief Engineer PW(R&B), Kashmir vide letter No. CE/RBK/ADM/205-06 dated 08.4.2021, intimated that Mr Rajesh Roshan Raina S/o Late Roshan Lal Raina R/o Tral Payeen, Pulwama appointed earlier as Junior Assistant had applied for the post of Statistical Assistant, advertised vide Adv/item No. 04/2017/153 under PM's Package for Kashmir Migrants and has been selected for the post of Statistical Assistant, Planning & Development Department under Hon'ble PM's Special Package item No. 153 (04 of 2017) for Kashmiri Migrants (Divisional Cadre No. letter candidate per in-service Kashmir) as SSB/Sel/Secy/2019/5671 dated 11.11.2019 of Secretary J&K Service Selection Board; and

Whereas, Mr. Rajesh Roshan Raina S/o Late Sh. Roshan Lal Raina R/o Tral Payeen, Pulwama has been subsequently appointed as Statistical Assistant vide order No. 466-DES of 2019 dated 13.12.2019 issued by Director General, Economics & Statistics Srinagar; and

Whereas, the Executive Engineer (R&B) Division Pulwama vide letter No. E-9/EEP/10588 dated 26,2.2021 reported that the said official stand

relieved from his office on 30.12.2019 and requested that the technical resignation of Mr. Rajesh Roshan Raina with effect from 30.12.2019 may be accepted; and

Whereas, as per Article-201 J&K CSR Vol-I, "Resignation of an appointment to take up another appointment in which service counts, is not to be held to be a resignation of the Government Service, provided the consent of the former departmental superior is obtained to accepting, such employment".

Now, therefore, in terms of Article-201 J&K CSR Vol-I, the technical resignation tendered (dated 24-12-2019) by Mr. Rajesh Roshan Raina S/o Late Roshan Lal Raina R/o Tral Payeen, Pulwama is hereby accepted with effect from 30-12-2019, however official shall obtain No Dues Certificate from concerned offices in due course of time.
