Subject:- Appointment against the post of Junior Engineer (Mechanical) in the Mechanical Engineering Department under Prime Minister's Special Package for Return and Rehabilitation of Kashmiri Migrants to the Kashmir Valley.

Reference:- DMRRR/MR/Sel/57/2019 dated: 20.03.2020 from Disaster of Management Relief, Rehabilitation and Reconstruction Department.

Sanction is hereby accorded to the appointment of Sh. Amit Dhar S/o Omkar Nath Dhar R/o F1 Quarters, DPS, Sheikhpura Migrant Colony, Sheikhpura Budgam Delhi Public School, 191111, Budgam, Sheikh Wadipora as Junior Engineer (Mechanical), under Prime Ministers Special Package for Return and Rehabilitation of Kashmiri Migrants to the Kashmir Valley. The appointee shall join in the office of Chief Engineer Mechanical Engineering Department Kashmir within 21 days from the date of issuing of this Government Order. His joining report shall become effective only after he executes an agreement in the "Form" prescribed under Jammu and Kashmir Migrants (Special Drive) Recruitment Rules, 2009 issued under Notification SRO-412 of 2009 dated 30/12/2009.

- i. The appointee shall be on probation for a period of two years and the Chief Engineer, Mechanical Engineering Department, Kashmir, shall allow the candidate to join only after production & verification of the following documents in original:-
- a. Education/Technical Qualification Certificates/Marks Sheet, which will also include whether technical degree/diploma is approved for employment in the UT of J&K.
 - b. Date of birth certificate/Matriculation Certificate.
 - c. Permanent Resident Certificate/State Subject.
 - d. Migrant Status Certificate issued by the competent authority from Relief and Rehabilitation Commissioner (Migrant).
 - e. Health Certificate issued by an officer not below the rank of Chief Medical Officer.

- f. Certificate from concerned authorities to the effect that no loan under self employment scheme has been obtained/availed by the candidate.
- g. Any other relevant certificates as are required under rules.

Further the appointment of the candidate shall be provisional and subject to the following conditions:-

- i. In case of receipt of an adverse report about his character and antecedents from CID Organization and on confirmation thereof by the State/Divisional/District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.
 - a. A person convicted by the competent court of an offence involving moral turpitude, heinous offences like murder, rape, dacoity, robbery under offences under NDPS, Act shall be regarded not fit for Government service.
 - b. During the course of verification of qualification, certificates, documents or any other relevant documents on the basis of which the candidate has been appointed turns out to be fake/ fictitious, the appointment shall be deemed to be cancelled ab-initio.
 - c. Salary of the appointee shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K to whom reference shall be made by the Chief Engineer, Mechanical Engineering Department Kashmir and verification of relevant certificates/documents is received from the concerned authorities.
 - d. The appointment order shall be governed under new pension scheme as per SRO-400 of 2009 dated 24/12/2009.
 - e. The inter-se-seniority of the appointee shall be fixed separately.
 - f. The appointment of the candidate as Junior Engineer (Mechanical) shall be subject to the outcome of the writ petition(s), if any, pending in the court of law.
 - g. If the appointee fail to join within a period of 21 (twenty one) days from the date of issuance of the appointment order, he shall forego his right to appointment which shall be deemed to have been cancelled abintio without any further notice in terms of Circular No.08-JK(GAD) of 2019 dated 04/12/2019.


