**WHEREAS**, the Chief Engineer, PW(R&B) Jammu has forwarded the case of Mr. Ramandeep Singh, Draftsman for acceptance of his Diploma and inclusion of the same into the seniority list of Diploma Holder Draftsman vide his letter No. CEJ/Estab/5/140-41 dated 08-04-2019 with following particulars:

**WHEREAS**, certificates submitted by the said Draftsman were forwarded to the concerned Board for verification and the concerned Board i.e, Punjab State Board of Technical Education and Industrial Training has verified the genuineness of certificates vide their letter No. PSB/Verification/2020/947 dated 07-08-2020; and

**WHEREAS**, case of the above named Draftsman has been examined in the department in light of relevant rules and it has been decided to accept his Diploma and include the same in the Seniority list of Draftsman Diploma Holders; and

**WHEREAS**, the said Draftsman has also given an undertaking in the shape of an affidavit attested by the Judicial Magistrate 1<sup>st</sup> Class which is reproduced here as:

*" that in case any information about his diploma is found bogus at any time, his diploma shall be deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against him in light of J&K Civil Services Rules, 1956".*

WHEREAS, objections were invited against the aforesaid Draftsman through the medium of notice under No. PW(R&B)/HRM/29/2019 dated 10.02.2021, which was published in local Daily news paper; and

WHEREAS, Chief Engineer PW(R&B) Department Jammu vide his letter No. CEJ/Estab/S/2815-17 dated 25.03.2021, has submitted that no objections were received by them in the matter so far; and

NOW, THEREFORE, Mr. Ramandeep Singh, Draftsman (Civil) shall henceforth be treated as Diploma Holder w.e.f. 13.06.2016 and shall be assigned seniority amongst the Draftsman (Civil) Diploma Holders at appropriate place as and when the same is notified.
