**Subject:** Appointment against the post of Junior Engineer (Mechanical) in the Mechanical Engineering Department, Kashmir under Prime Minister's Special Package for Return and Rehabilitation of Kashmiri Migrants to the Kashmir Valley.

**Government Order NO. 20 -PW(R&B) of 2020**  
**Dated: 23 -01-2020**

Whereas, vide Government Order No.270-PW(R&B) of 2019 dated 30/05/2019 among others Mr. Ashwani Kimar Raina S/o Triloki Nath Raina R/o 5/49, Patoli Mangotrain, Near Mast Baba Ashram Jammu has been appointed as Junior Engineer (Mechanical) in the Public Works (R&B) Department, Kashmir under the Hon'ble Prime Minister's Special Package for Kashmiri Migrants.

Whereas, above mentioned candidate approached this department through a representation alongwith affidavit duly attested by the 2<sup>nd</sup> Additional Munsiff Judicial magistrate (1<sup>st</sup> Class) Jammu stating that he is unwilling to join the services for the post of Junior Engineer (Mechanical) in the Public Works (R&B) Department, Kashmir in terms of Government Order No.270-PW(R&B) of 2019 dated 30/05/2019, for which he will neither stake any kind of claim to the department nor for re-appointment in future, and will have no objection, in case any other selectee in the merit list is appointed in the department in his place.

Whereas, the Department of Disaster Management vide O.M.DMRRR/MR/Sel/57/2019 dated 01/04/2019 had forwarded selection list of J&K Services Selection Board in respect of 15 candidates for the post of "Junior Engineer" Mechanical under the Hon'ble Prime Minister's Special Package for Kashmiri Migrants. The appointment order for these candidates was issued by the PW(R&B) Department vide Government Order No.270-PW(R&B) of 2019 dated 30/05/2019. In terms of said order the candidates were required to join before the Chief Engineer, Mechanical Engineering Department, Kashmir within the stipulated period of 30 days failing which appointment would stand cancelled without any further notice and as per intimation from the Mechanical Engineering Department, Kashmir, one candidate, namely, Shri Ashwani Kumar Raina S/o Triloki Nath Raina R/o Pulwama Kashmir has not joined in the department within the stipulated time of 30 days i.e. 30/06/2019.

Now therefore, sanction is hereby accorded to the:-

- i. Cancellation of appointment of Mr. Ashwani Kimar Raina S/o Triloki Nath Raina R/o 5/49, Patoli Mangotrain, Near Mast Baba Ashram Jammu ab-initio who stands appointed as Junior Engineer (Mechanical) in the Public Works (R&B) Department, Kashmir vide Government Order No.270-PW(R&B) of 2019 dated 30/05/2019 under the Hon'ble Prime Minister's Special Package for Kashmiri Migrants; and
- ii. appointment of Mr. Amit Raina S/o Ashok Kumar Raina R/o H.No.102, Bari Barhamana Sarore, Neher, Kashmir Colony, Indane Gass Plant, 181133, Samba, Kartholi as Junior Engineer (Mechanical) against the vacancy of Junior Engineer (Mechanical) accrued due to non-joining of Mr. Ashwani Kimar Raina S/o Triloki Nath Raina R/o 5/49, Patoli Mangotrain, Near Mas Bab Ashram Jammu, under the Hon'ble Prime Minister's Special Package for Kashmiri Migrants. His joining report shall become effective only after he executes an agreement in the "Form" prescribed under Jammu and Kashmir Migrants (Special Drive) Recruitment Rules, 2009 issued under Notification SRO-412 of 2009 dated 30/12/2009.
- iii. The appointee shall be on probation for a period of two years and the Chief Engineer, Mechanical Engineering Department, Kashmir shall allow the candidate to join only after production & verification of the following documents in original:-
  - a. Education/Technical Qualification Certificates/marks Sheet, which will also include whether technical degree/diploma is approved for employment in UT J&K.
  - b. Date of birth certificate/Matriculation Certificate.
  - c. Permanent Resident Certificate/State Subject.
  - d. Migrant Status Certificate issued by the competent authority from Relief and Rehabilitation Commissioner (Migrant).
  - e. Age and Healthy Certificate issued by an officer not below the rank of Chief Medical Officer.
  - f. Certificate from concerned authorities to the effect the no loan under self employment scheme has been obtained/availed by the candidate.
  - g. Reserved category certificate if required.
  - h. Any other relevant certificates as are required under rules.

Further the appointment of the candidate shall be provisional and subject to the following conditions:-

- i. In case of receipt of an adverse report about his character and antecedents from CID Organization and on confirmation thereof by the State/Divisional/District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.
- ii. A person convicted by the competent court of an offence involving moral turpitude, heinous offences like murder, rape, dacoity, robbery under offences under NDPS Act shall be regarded not fit for Government service.
- iii. During course of verification qualification, certificates, documents or any other relevant documents on the basis of which candidates have been appointed turns out to be fake/fictitious, the appointment shall be deemed to be cancelled ab-initio.
- iv. Salary of the appointee shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K (to whom reference shall be made by the Chief Engineer (Mechanical) Kashmir and verification of relevant certificates/documents is received from the concerned authorities.
- v. The appointment order shall be governed under new pension scheme as per SRO-400 of 2009 dated 24/12/2009.
- vi. The inter-se-seniority of the appointee shall be fixed separately.
- vii. The appointment of the candidate as Junior Engineer (Mechanical) shall be subject to the outcome of the writ petition(s), if any, pending in the court of law.



- viii. The appointment of the candidate shall be deemed cancelled, if he will not join the duties within 30 days from the date of issuance of appointment order.

In case, the appointee migrates from the Kashmir Valley at any time during his service tenure, for any reason whatsoever, his appointment/service shall stand terminated without any notice by itself by the action of his migration.


