In case of failure to join within the stipulated period, their appointments shall be deemed to have been cancelled without any further notice.

The appointee(s) shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:

1. Academic/Technical Qualification Certificates.
2. Matriculation /Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Domicile Certificate.
5. Certificate from the District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under the self-employment scheme has been availed by the appointee(s).
6. Relevant category certificate.

The appointment of the above candidates, as Junior Assistant in PW(R&B) Department, shall further be subject to the following conditions that:-

- i. The appointee(s) shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about their character and antecedents is received from the Additional Director General of Police, (CID), J&K, they shall have no right to claim their appointment as Junior Assistant in the Public Works (R&B) Department, and their appointment, as such, shall be deemed to have been cancelled ab-initio;
- ii. Verification/genuineness of the qualification, reserved category certificate and recognition of the Computer Institute from the concerned issuing authorities.

The salary of the appointee(s) shall not be drawn and disbursed to them unless the satisfactory report in respect of (i) and (ii) above is received in their favour; and

If, on verification, the certificates produced by the appointee(s) proved to be fake or forged, their appointment shall stand also cancelled ab-initio; and

The appointment of the above candidates shall be governed as per S.O 192 dated 17th of June, 2020 issued by the General Administration Department.

The inter-se-seniority of the appointee(s) shall be drawn in accordance with the merit secured by the appointee(s) in the selection list prepared by the J&K Services Selection Board; and

The appointee(s) shall qualify the J&K Secretariat Assistant Training Course during the period of probation; and

The appointment of the above candidate(s) shall be subject to outcome of writ petition(s), if any, pending before the Competent Court of law.
