Acceptance of Degree acquired by Mr. Abdul Rouf Khan Junior Engineers (Mech) and inclusion of his name in the seniority list of Degree holders JE (Mech).

Government Order No. 21 -PW(R&B) of 2023
Dated: 31 .05.2023

Whereas, as per provisions of J&K Engineering (Subordinate)
Service Recruitment Rules, 1997, a Junior Engineer, Diploma holders after
acquiring Degree in relevant branch of Engineering is to be treated as
Degree holder for the purpose of seniority from the date of completion/
passing of Degree; and

Whereas, the Mission Director, Jal Jeevan Mission J&K vide his letter No.SMD/JJM-J&K/01/2020-21/1086 dated 27.12.2021 has forwarded the case of Mr. Abdul Rouf Khan Junior Engineer (Mech) for inclusion of his degree and inclusion of his name in the seniority list of degree holders Junior Engineers (Mechanical) whose particulars are given as under:-

Whereas, the case was examined in the department and Degree/ marks certificates of the above-named Engineers were forwarded to the concerned Universities on 19.01.2022 for verification of genuineness of Degree. In response, the concerned University /Institution vide their



communication No. JK-19464/31/22 dated 21.04.2022 has verified the degree certificate of the incumbent.

Whereas, the above incumbent has also produced undertaking in the shape of Affidavit dully attested by the 1st Class Judicial Magistrate affirming therein that in case any of the certificate/ documents submitted by him regarding treatment as Junior Engineer degree holder is found to be fake or any statement made by him in this regard is found untrue at any time, he shall be personally responsible for the same.

Whereas, clarifications with regard to validity/ equivalence of Degree were sought from AICTE and in response to which the AICTE vide their communication No.NWRO/ AICTE/ Verification/ 2020-21 dated 17.03.2021 has forwarded the clarification issued on the subject and the operative part of clarification are reproduced as under:-

"The Institute of Civil Engineering (India) Ludhiana are Professional Bodies conducting technical courses and awarding associate membership to the candidates who qualify the examination conducted by them. In this regard, AICTE has issued a circular F.No.13-56/ PC/ ODL-Mode/ AICTE/ 2020 recognition of certification awarded by Professional Bodies/ Institutions dated 23.11.2020, which is self explanatory. The professional societies recognized by MHRD upto 31.05.2013 were permitted to conduct section A&B exams and treated equivalent to degree upto 31.05.2013 only.

Whereas, the operative part of Circular No.F.No.13-56/ PC/ ODL- Mode/ AICTE/ 2020 dated 23.11.2020 issued by the AICTE is reproduced as under:-

Thus all those students who were enrolled with these Institutions as per the above MHRD OM with permanent recognition upto 31.05.2013 stand recognized

and public notice was issued on 31.10.2017 accordingly. However, AICTE recognition is not course specific and this is only the endorsement of the decision of MHRD in this regard. Hon'ble Supreme Court in its judgement dated 13.08.2019 in the case MA No.2367 of 2018 in Civil Appeal No.17922 of 2017; Institution of Mechanical Engineers V/s State of Punjab & Ors has endorsed the decision of MHRD and AICTE Public Notice issued in 2017.

Whereas, relevant extract of Public Notice issued by the AICTE on 31.10.2017 reads as under:-

Whereas, on re-examining of the case, it has been observed that there is a case to accept the Degree of the official from the date of passing Degree and also include his name at appropriate place in the relevant seniority list of Degree Holders Junior Engineers (Mech) as and when the same is notified afresh by the department and also exclusion of his name from the seniority list of Junior Engineers (Mech-Diploma holders) when it is revised/ updated.

Whereas, the case was further examined in the department and a notice was issued on 23.05.2022 for inviting therein objections from the embers of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer MED, Kashmir vide letter No. MED/K/Adm/1809-11 dated 23.07.2022 has intimated that his office has not received any objection(s) from any member(s) of cadre regarding decision taken by the Department in the instant case.

Whereas, the Finance Department has issued circular instructions under endorsement No.A/HACM (2012)-PMO-49 dated 01.02.2019 clarifying therein that the advance increments to degree holders on their appointment as Junior Engineers are available on initial

appointment and not at the time of acquiring degree after entry into Government Service as Diploma holder.

Now, therefore, Er. Abdul Rouf Khan, Junior Engineer (Mechanical) Diploma holder shall henceforth be treated as Degree holders Junior Engineers (Mech) from the date of passing of Degree and his name shall be included at appropriate place in the seniority list of Degree Holders Junior Engineers (Mech) as and when the same is notified afresh. Besides, his name shall deemed to be excluded from the seniority list of Junior Engineers (Mech) Diploma holders. However, the pay of these Engineers shall be regulated as per circular instructions issue by the Finance Department under endorsement No.A/HACM (2012)-PMO-49 dated 01.02.2019.
