On the recommendation of the J&K Services Selection Board and in continuation to Government Order No. 10-PW(R&B) of 2022 dated 11.01.2022, sanction is hereby accorded to the appointment of Ubaid Gulzar S/o Gulzar Ahmad Kuchy R/o 56, Kaddar A Kadder Kulgam under EWS category (Application No. 5339678729 & Roll No. 261469369049) against the post of Class-IV (Road Worker) in the Divisional Cadre Kashmir in the Pay Level of SL-1 (14800-47100) in the Public Works (R&B) Department:-

- a) The appointee shall report to the office of the Chief Engineer, PW(R&B) Department, Kashmir within a period of 21 days from the date of issuance of this order and if the candidate fails to join within the stipulated time, he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further Notice.
- b) The appointee shall be allowed to join on production of the following documents/certificates (in original) to be verified subsequently: -
  - i. Academic/Qualification Certificate.
  - ii. Matriculation/Date of Birth Certificate
  - iii. Health certificate from the concerned Chief Medical Officer of the District.
  - iv. Domicile Certificate from the competent Authority.
  - v. Certificate from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been availed by the appointee.
  - vi. Valid relevant Category Certificate, if any applicable.
- c) The appointment of the aforesaid candidate shall further be subject to the following conditions:-
  - a. The appointee shall furnish an Undertaking in the shape of Affidavit to the effect that the appointee have no criminal records and also not facing any criminal proceedings in any Court of Law.

- b. If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee for appointment as (Class-IV) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- c. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of qualification / date of birth/relevant category certificate are received from the concerned authority.
- d. The appointment of the appointee shall be governed in terms of Jammu and Kashmir Probationer (Condition of Service, pay and Allowances) and Fixation of Tenure Rule, 2020 notified vide S.O. 192 of 2020 dated 17.6.2020.
- e. The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department.
- f. The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
- g. The appointment of the above candidate shall be subject to outcome of any petition(s), if any, pending before Competent Court of Law.


