Whereas, the General Administration Department vide O.M. No. GAD/ MTGORBIV/ 63/2021-09-GAD dated 19.10.2021 forwarded the selection list recommended by the Services Selection Board vide letter No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 to this department for issuing appointment orders in respect of 622 candidates in the Public Works (R&B) Department as per the standard terms and conditions already issued from time to time by the Government; and

Whereas, on the recommendations of the J&K Services Selection Board duly endorsed by the General Administration Department, the department issued formal appointment orders in favour of the candidates whose verification reports got received from the Criminal Investigation Department duly endorsed by the concerned Deputy Commissioners; and

Whereas, the appointee(s) had been directed to report to the office of the Chlef Englneer, PW(R&B) Department Jammu/Kashmir within a period of 21 days from the date of Issuance of order and such candidates who fail to join within the stipulated time, shall forego their right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice; and

Whereas, the appointment of the candidate(s) had been further subjected to condition, that if, on verification of the qualification certificate/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee(s) for appointment as (Class-IV) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her; and

Whereas, vide Government Order No.331-PW(R&B) of 2021 dated 24.10.2021, among others, Shri Yasir Rashid (Road Worker) S/o Abdul Rashid Bhat R/O 40- Reshipora Arrigutnoo Kulgam under RBA category was appointed as Road Worker in the Kashmir Division; and

Whereas, the Chief Engineer PW(R&B) Department, Kashmir vide his office communication No. CE/RBK/ADM/7226-28 dated 13.06.2022 informed that the Tehsildar Pahloo vide communication No.24/BGQ/TP dated 27.04.2022 reported that the RBA Certificate of Mr. Yasir Rashid S/o Abdul Rashid Bhat R/o Reshipora Arrigutnoo Kulgam bearing No.67/BGQ/RBA/2021 dated 22.06.2021 has been cancelled ab initio.



Now, therefore, the appointment of Shri Yasir Rashid (Road Worker) S/o Abdul Rashid

Bhat R/O 4D- Reshipere Arrigutnoo Kulgam selected under the reserved category of RBA, under

the provisions of the Jammu & Kashmir Appointment to the post of Class-IV (Special
Recruitment) Rules, 2020 pursuant to Advertisement Notification No.01 of 2020 dated

25.05.2020, is hereby cancelled ab-initio in terms of stipulated conditions in the appointment
