Sanction is hereby accorded to the constitution of committee under the chairmanship of Additional Secretary (Legal) Public Works (R&B) Department, comprising of following members for review of all the pending litigations in coordination with all Head of the department/PSUs under the administrative control of Public Works (R&B) Department and shall work out a roadmap to clear the pendency within a stipulated time frame and the committee shall also suggest a mechanism to evaluate the performance of the Law officers viz-a-viz disposal of the cases by them:-

- 1. Law Officer of office of the Chief Engineer Public Works (R&B) Kashmir or representative.
- 2. Law Officer of office of the Chief Engineer Public Works (R&B) Jammu or representative.
- 3. Law Officer of office of the Chief Engineer PMGSY (JKRRDA) Kashmir or representative.
- 4. Law Officer of office of the Chief Engineer PMGSY(JKRRDA) Jammu or representative.
- 5. Law Officer of office of the Chief Engineer J&K Mughal Road Project or representative.
- 6. Law Officer of office of the Chief Engineer Design Inspection & Quality Control Department or representative.
- 7. Law Officer of Chief Engineer Mechanical Engineering Department Jammu or representative.
- 8. Law Officer of office of the Chief Engineer Mechanical Engineering Department Kashmir or representative.

The members of the committee shall identify the cases as are not worth contesting and submit the list of such cases to the committee constituted for the purpose in the Department of Law Justice & Parliamentary Department. The committee will work under overall control of the Principal Secretary to the Government Public Works (R&B) Department.
