Treating Junior Engineer (Civil) Diploma Holder as Degree Holder (Civil).

Government Order No: 758 PW(R&B) of 2020 Dated: 14-09-2020

WHEREAS, as per provisions of J&K Engineering (Subordinate) Service Recruitment Rules, 1997 and precedence adopted in the Department, a Junior Engineer Grade-II, Diploma Holder after acquiring degree in relevant branch of engineering is treated as "Degree Holder" for the purpose of seniority from the date of completion/passing of Degree; and

WHEREAS, the Chief Engineer, PW(R&8) Kashmir vide letter No. CE/RBK/ES/23032 dated 14-10-2015 forwarded the case of Mr. Babar Ashraf Bhat, Junior Engineer (Civil)-Diploma Holder for inclusion of his name in the seniority list of Junior Engineers (Degree Holders); and

Whereas, the case of the official was examined in the department and found that he has been appointed as Junior Engineer (Civil) on the basis of Diploma qualification vide Government Order No.234-PW(R&8) of 2015 dated 07.09.2015 and acquired B.E in Civil Engineering from SSM College of Engineering, Pattan, Baramulla, Kashmir. Details of the official are as under:-

WHEREAS, vide this department's letter dated 14-11-2017 copies of degree certificate and other relevant documents were forwarded to the concerned Institution for verification and the concerned Institute has confirmed the genuineness of certificate vide letter No.SSM/E&P/17/3832/Adm dated 04-12-2017; and





WHEREAS, the said official has also produced an undertaking on an affidavit stating therein that in case any information about his degree is found bogus at any point of deemed to be cancelled time in his service, his degree shall ab-initio and action as warranted under rules shall be initiated against him in light of the J&K Civil Service (Classification, Control and Appeal) Rules, 1956; and

a notice under No. WHEREAS, objections were invited through PW(R&B)/NG/46/2015 dated 26-09-2018, which was published in news papers "Rising Kashmir" dated 24th May, 2019 & "Kashmir Times" dated 28th May 2019 and the department has not received any objection(s) within stipulated time period; and

Whereas, Finance Department has issued circular instructions vide endorsement No.A/HCM (2012)-PMO-49 dated 01.02.2019 and clarified that the advance increments to degree holders on their appointment as Junior Engineers are available on initial appointment and not at the time of acquiring degree after entry into Government service as Diploma holder.

NOW, THEREFORE, Mr. Babar Ashraf Bhat, Junior Engineer (Civil) Diploma Holder shall henceforth be treated as Degree Holder w.e.f 03.04.2017, and shall be assigned seniority amongst the Junior Engineers (Civil) Degree Holders at an appropriate place as and when the same is notified. However, the pay of the official shall be regulated as per Circular Instructions issued by Finance Department under endorsement No. A/HCM/2012-PMO-49 dated 01-02-2019.
