The appointee shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

- Educational/Technical Qualification issued by the recognized Institute/University valid for employment.
- Matriculation/Date of Birth Certificate.
- Domicile certificate issued by the competent authority.
- 4. Health Certificate from the concerned District Chief Medical Officer.
- Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any self employment scheme has been availed by the candidate.
- Valid relevant category certificate issued by the competent authority, if any applicable.



The appointment of the above candidate shall further be subject to the following conditions:-

- The appointee shall furnish an undertaking in the shape of an africavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings to any court of law.
- II. The salary of the appointee shall not be drawn and disbursed to film unless satisfactory report in respect of genuineness of their qualification/degree certificate/Date of birth/relevant category certificate is received from the concerned issuing authority.
- If an verification, the certificates produced by the appointee proved to be take or forged, his appointment shall stand cancelled ab-initio.
- iv. The appointment of the sandidate shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 of 2020 dated 17:06-2020.
- The appointee shall qualify the 38K Secretariat Assistant Training Course during the period of probation.
- vi. The inter-se-seniority of the appointee shall be determined in accordance with the ment secured by the appointee in the selection list prepared by the Services Selection Board.
- vii. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before any competent court of law.
