On the recommendations of the J&K Services Selection Board and in continuation of Government Order No. 02-PW(R&B) of 2023 dated 02.01.2023, sanction is hereby accorded to the temporary appointment of Ubaid Ahmad Naik S/o Sh. Fayaz Ahmad Naik (Sel. S.No- 1-EWS-W-130, D.V.S.No. 210-KMR, Registration No. 145433, Roll No. 1035712 D.O.B- 05.03.1996, Permanent District Kulgam, Permanent Tehsil- Kulgam) (under wait list) against the post of Junior Engineer (Civil) In the Pay Level-6 (35400-112400) under EWS category, in the Public Works (R&B) Department.

Consequent upon his appointment, the appointee shall report to the office of the Chief Engineer, R&B Kashmir within a period of twenty one (21) days from the date of issuance of order. In case the candidate fails to join within the stipulated time period, his appointment shall be deemed to have been cancelled ab-initio without any notice.

The appointee shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

- Educational/Technical Qualification issued by the recognized Institute/University valid for employment
- Matriculation/Date of Birth Certificate from recognized education Board.
- Domicile certificate issued by the competent authority.
- 4. Health Certificate from the concerned District Chief Medical Officer.
- Valid relevant category certificate issued by the competent authority, if any applicable.
- 6. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its

recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

The appointment of the above candidate shall further be subject to the *following conditions:-

- The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any court of law.
- The salary of the appointee shall not be drawn and disbursed to them unless satisfactory report in respect of genuineness of their qualification/degree certificate/Date of birth/relevant category certificate is received from the concerned issuing authority.
- The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by the appointee(s) in the selection list prepared by the Services Selection Board.
- The appointee shall be on probation for a period of two (02) years as per Rule 20 of J&K Civil Services (CCA) Rules, 1956.
- The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before any competent court of law.
