The appointee(s) who belongs to Jammu/Kashmir province shall report in the office of the Chief Engineer, Mechanical Engineering Department, Jammu/Kashmir respectively within a period of twenty one (21) days from the date of issuance of order. In case any candidate falls to join within the stipulated time period, his/her appointment shall be deemed to have been cancelled ab-initio without any notice.

The appointee(s) shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

- Educational/Technical Qualification Degree (Degree certificates) issued by the recognized Institute/University valid for employment
- 2. Matriculation/Date of Birth Certificate.
- 3. Domicile certificate issued by the competent authority.
- 4. Health Certificate from the concerned District Chief Medical Officer.
- Certificate from the District Industries Centre (DIC) and District Employment and Counselling Centre to the effect that no loan under any self employment scheme has been availed by the candidate.
- Valid relevant category certificate Issued by the competent authority, if any applicable.

The appointment of the above candidates shall further be subject to the following conditions:-

- i. The appointee(s) shall furnish an undertaking in the shape of an affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any court of law.
- ii. The salary of the appointee(s) shall not be drawn and disbursed to them unless satisfactory report in respect of genuineness of their qualification/degree certificate/Date of birth/relevant category certificate is received from the concerned issuing authority.
- III. The appointment of the candidates shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 of 2020 dated 17.06.2020.



- The inter-se-seniority of the appointees shall be determined in accordance with the iv. merit secured by the appointee(s) in the selection list prepared by the Services Selection Board.
- The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending before any competent court of law.
