Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Scl/Class-IV/2021/7103-11 dated 18.10.2021 and General Administration Department's O.M. No. GAD/MTGRBIV/63/2021-09-GAD dated 19.10.2021, Mr. Ankit Bhagat S/o Tilak Raj Bhagat R/o H.No. 455 Hazuri Bagh Road Bohri Talab Tillo Jammu Ward No. 41 Jammu, Jammu under Application No. 196402112 Roll No. 181258142909 was among others, appointed to the post of Road Worker vide Government order No. 323-PW(R&B) of 2021 dated 22.10.2021; and

Whereas, vide Government order No. 323-PW(R&B) of 2021 dated 22.10.2021, among others, the services of Mr. Ankit Bhagat were placed at the disposal of the Chief Engineer, PW(R&B) Department Jammu for further posting; and

Whereas, while being posted in the office of the Chief Engineer, PW(R&B) Department, Jammu, Mr. Ankit Bhagat joined Government service on 27.10.2021 and posted in PWD(R&B) Construction Division No. III Jammu vide office order No. CEJ/ADM/320 of 2021 dated 16.11.2021 by the Chief Engineer; and

Whereas, subsequent to his appointment, the Chief Engineer, PW(R&B) Department Jammu vide letter No. CEJ/Estab/2664 dated 07.01.2022 reported that the official has tendered his resignation in the Public Works (R&B) Department before Executive Engineer, Division No. III, Jammu on 21.12.2021 on the grounds that his domestic circumstances do not allow him to continue his services as Road Worker; and

Whereas, the Chief Engineer, PW(R&B) Department, Jammu forwarded his request to the Public Works (R&B) Department for acceptance of his resignation.



Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that the official is still on probation and has not qualified the prescribed service, therefore, in exercise of the powers conferred under Rule 22(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Ankit Bhagat (Road Worker) S/o Tilak Raj Bhagat R/o H.No. 455 Hazuri Bagh Road Bohri Talab Tillo Jammu Ward No. 41 Jammu, Jammu is hereby accepted and he is discharged from the service w.e.f. 21.12.2021.
