The appointee(s) shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

- Educational/Technical Qualification Degree issued by the recognized Institute/University valid for employment
- 2. Matriculation/Date of Birth Certificate issued by the recognized Education Board.
- 3. Domicile certificate issued by the competent authority.
- 4. Health Certificate from the concerned District Chief Medical Officer.
- 5. Valid relevant category certificate issued by the competent authority, if any applicable.
- 6. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

The appointment of the above candidates shall further be subject to the following conditions:-

The appointee(s) shall furnish an undertaking in the shape of an affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any court of law.

- II. If on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee for appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.
- iii. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the verification rolls (V-Rolls), as available through online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee, or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment ab-initio, without any further notice.

iv. The salary of the appointee(s) shall not be drawn and disbursed to them unless satisfactory report in respect of genuineness of their qualification/degree certificate/Date of birth/relevant category certificate is received from the concerned issuing authority.

- v. The appointment of the candidates shall be governed by the New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- vi. The appointee(s) shall be on probation for a period of 02 years.
- vii. The cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department.
- viii. The appointment shall be cancelled abinitio, if it is found that the candidates are having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
- bx. The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending before any competent court of law.
