- 6. Valid relevant category certificate issued by the competent authority, if any

The appointee(s) shall furnish an undertaking in the shape of an affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any court of law.

The salary of the appointee(s) shall not be drawn and disbursed to them unless satisfactory report in respect of genuineness of their qualification/degree ii. certificate/Date of birth/relevant category certificate is received from the concerned issuing authority.

The appointment of the candidates shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of iii.
