Whereas, the above incumbents have also produced undertakings in shape of affidavits affirming therein that:-

- in case any information about their certificates is found bogus at any time, the same shall be deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against them in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956.
- they shall not claim for seniority position ahead/ over and above the direct recruited JEs of that particular year during which these incumbents are promoted as J.Es on the basis of Degree/ Diploma.

Whereas, on re-examination of the case, it has been observed that there is a case to accept Degree/ Diploma certificates of the above named four Draftsmen (Mechanical) from the date of their initial appointment and also include their names at appropriate places in the relevant seniority list as and when the same is notified afresh by the department.

Whereas, the case was further examined in the department and two notices for inviting therein objections from the members of the cadre were issued on 20.05.2022 and 22.06.2022 respectively. In response, the Chief Engineer, MED, Jammu vide his communication No.CEM/ J/ Estt/ 2086 dated 04.08.2022 has intimated that his office has not received any objection from any person after issuance/ publication of notices in respect of the above named four (4) Draftsmen (Mechanical).

Now therefore, the following Draftsmen (Mechanical) shall henceforth be treated as Degree/ Diploma holder Draftsman (Mechanical) from the date of their initial appointment as Draftsmen (Mech) and subsequently their names shall be included at appropriate places in the relevant seniority list amongst the Degree/ Diploma Holders Draftsman (Mechanical) as and when the same is notified afresh by the Department, subject to the condition that after their promotion as JE (Mechanical), they shall not claim for seniority position ahead/ over and above the direct recruited JEs of that particular year during which they are promoted as JEs:-
