In continuation of Government Order No. 137-PW(R&B) of 2022 dated: 19 04.2022, 160-PW(R&B) of 2022 dated: 10.05.2022 and 223-PW(R&B) of 2022 dated 04-07-2022, and as recommended by the J&K Public Service Commission, sanction is hereby accorded to the temporary appointment of **Shri Shiekh Zahid Nisar S/o Shiekh Nisar Ahmad** R/o 160, Near Jamia Masjid Tarigam, Kulgam under OM/PHC Category against the post of Assistant Engineer (Civil) UT Cadre, in the pay Level-8A (50700-160600) in the Public Works (R&B) Department with immediate effect.

The appointee shall report to the Additional Secretary to the Government, Public Works (R&B) Department, Civil Secretariat, Srinagar within a period of twenty one (21) days from the date of issuance of this Government Order. In case he fail to join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any Notice.

The appointee shall be allowed to join after production of the following certificates/documents (in original) to be verified subsequently:-

- i. Educational/Technical Qualification Degree (Degree Certificate) issued by the recognized Institute/University valid for employment.
- ii. Matriculation/ Date of Birth Certificate.
- iii. Domicile Certificate issued by the Competent Authority.
- iv. Health Certificate from the concerned District Chief Medical Officer.
- v. Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any self employment scheme has been availed by the candidate.
- vi. Valid relevant category certificate issued by the Competent Authority, if any applicable.

Besides, the appointment of the above candidate shall further be subject to the following conditions:

- a) The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee has no criminal record and is not facing any criminal proceedings in any Court of law.
- b) The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of his qualification/degree certificate/Date of Birth/relevant category certificate is received from the concerned issuing authority.
- c) The appointment of the candidate shall be governed in terms of Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 of 2020 dated 17.06.2020.
- d) The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by the appointee in the selection list prepared by the J&K Public Service Commission.
- e) The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of Law.
