Extract of Public Notice issued by the AICTE on 31.10.2017 reads as under:-

August 3, 2017 decided to recognize equivalence for all purposes including Higher Education & Employment to Technical Courses conducted by various Processional Bodies/ Institutions which were duly recognized by MHRD with permanent recognition upto 31st May 2013. Thus all those students who were enrolled with these institutions with permanent recognition upto 31.05.2013, stand recognized.

Whereas, the case was examined in light of above clarifications of AICTE and Degree/ marks certificates of Er.Zahoor Ahmad Rather and Er.Arshad Ahmad Handoo, Junior Engineers (Civil) were forwarded to the concerned University on 09.08.2021 for verification/ genuineness of their Degrees. In turn, the Controller of Examination, Institution of Engineering (India) Ludhiana vide their letter No.ICE (I) E-21/ 37528 dated 11.08.2021 has verified the Degrees acquired by the concerned Engineers.

Whereas, the above incumbents have also produced undertakings in the shape of Affidavits dully attested by the 1st Class Judicial Magistrate, affirming therein that in case any information about their Degrees is found fraudulent/ bogus at any time during service, the same shall be deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against them in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

Whereas, the case was re-examined and a notice was issued on 25.08.2021 for inviting objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer, PW(R&B) Kashmir vide his letter dated 21.09.2021 has intimated that Notice was published in newspapers and also has forwarded a copy of anonymous representation filed on the subject which was examined in the department and found devoid of merit.

Whereas, the case was further examined in the department and it has been observed that there is a case to accept their Degrees from the date of passing Degrees and include their names at appropriate place/s in the relevant seniority list of Junior Engineers (Civil) Degree Holders as and when the same is notified afresh and also exclude their names from the seniority list of Junior Engineers (Civil- Diploma holders).

Whereas, the Finance Department has issued circular instructions under endorsement No.A/HACM (2012)-PMO-49 dated 01.02.2019 clarifying therein that the advance increments to degree holders on their appointment as Junior Engineers are available on initial appointment and not at the time of acquiring degree after entry into Government Service as Diploma holder.

Now, therefore, Er.Zahoor Ahmad Rather and Er.Arshad Ahmad Handoo, Junior Engineers (Civil) (Diploma holders) shall henceforth be treated as Junior Engineers (Civil) Degree holders and their name(s) shall be included at appropriate place(s) in the seniority list of Junior Engineers (Civil) Degree Holders as and when the same is notified afresh, besides, their names shall be deemed to be excluded from the seniority list of Junior Engineers (Civil) Diploma holders. However, the pay of these Engineers shall be regulated as per circular instructions issue by the Finance Department under endorsement No.A/HACM (2012)-PMO-49 dated 01.02.2019.
