Whereas, as per provisions of J&K Engineering (Subordinate) Service Recruitment Rules, 1997, a Junior Engineer, Diploma holder after acquiring Degree in relevant branch of Engineering is to be treated as Degree holder for the purpose of seniority from the date of completion/ passing of Degree; and

Whereas, this department has received following cases for acceptance of their Degrees and subsequent inclusion of their names in the seniority list of Junior Engineers (Civil) Degree holders:-

Whereas, with regard to issue of equivalence of Degrees obtained from the Institutions/ Universities other then AMIE Kolkatta, the department has taken up the matter with the AICTE for clarifications. In response the AICTE vide their communication No.NWRO/ AICTE/ Verification/ 2020-21 dated 17.03.2021, among others, has clarified as under:-

"The Degree/ Diploma are verified / validated by the issuing authority i.e concerned University/ Institution only However, reply in respect of





verification status of the Institutes from there officers/ employees have got their degrees are submitted herewith in a tabular form for action in this regard:-

Information	Clarification/ reply from AICTE
IGNOU (Distance Education)	IGNOU does not come under the purview of AICTE. However AICTE has issued a circular AICTE / P&AP/ IGNOU/ misc/ 2020 dated 25.11.2020 which is enclosed herewith as Annexure-I. This is as per the approval of EC/ Council in the basis of Supreme Court judgment.

Relevant extract of Circular issued under No.F/No.AICTE/P&AP/ IGNOU/ Misc/ 2020 dated 25.11.2020 reads as under:-

Whereas, the case was re-examined in the Department and the Degrees/marks certificates of the above named Engineers were forwarded to the Registrar, IGNOU, New Delhi on 08.02.2021 for verification of genuineness of their Degrees. In turn the Authorized Signatory, IGNOU, New Delhi vide their letters dated 17.02.2021 has verified the genuineness of the degrees/ documents acquired by the above officials.

Whereas, the above incumbents have also produced undertakings in the shape of Affidavits dully attested by the 1<sup>st</sup> Class Judicial Magistrate, affirming therein that in case any information about their Degrees is found fraudulent/ bogus at any time during service, the same shall be deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against them in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

Whereas, the case was further examined in the department and it was observed that there is a case to accept the degrees of the above named Engineers and include their names in the seniority list of Junior Engineers Degree Holders (Civil). Accordingly notice for inviting therein objections from the members of the cadre was issued on 03.05.2021. In response the Chief Engineer, R&B, Kashmir vide his letter No.CE/RBK/ ADM/ 6359 dated 02.06.2021 has intimated that the notice was published in the newspaper, however his office has not received any objection from any official regarding proposed action.

Whereas, the Finance Department has issued circular instructions under endorsement No.A/HACM (2012)-PMO-49 dated 01.02.2019 clarifying therein that the advance increments to degree holders on their appointment as Junior Engineers are available on initial appointment and not at the time of acquiring degree after entry into Government Service as Diploma holder.

Now, therefore, the following Junior Engineers (Civil) (Diploma holders) shall henceforth be treated as Junior Engineers (Civil) Degree holders from the date of passing of Degrees and their name(s) shall be included at appropriate place(s) in the seniority list of Junior Engineers (Civil) Degree Holders as and when the same is notified afresh, besides, their names shall be deemed to be excluded from the seniority list of Junior Engineers (Civil) Diploma holders:-
