## Government Order No.307-PW(R&B) of 2024 Dated: 17-10-2024

On the recommendations of the J&K Services Selection Board received through the General Administration Department and in continuation of the Government Order No. 291-PW(R&B) of 2024 dated 04.10.2024, sanction is hereby accorded to the appointment of Mr. Zamin Nazir S/o Nazir Ahmad Zaqoo (SL, S.No.3225 Roll No. 201351180384 DOB: 17.08.1999 Domicile District Anantnag; Category-RBA; Selection Category= RBA) against the post of Multi Tasking Staff (MTS) in the Pay Level SL-1 (14800-47100) in the UT Cadre, in the Public Works (R&B) Department in respective category of nomenclature of the post to be allotted by the concerned Chief Engineer/HOD.

Consequent upon his appointment, the appointee shall report to the Chief Engineer, PW(R&B) Department, South Kashmir within a period of twenty one (21) days from the date of issuance of order. In case the candidate fails to join within the stipulated time period, his appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join on production of the following documents/certificates (in original) to be verified subsequently:-

- Academic/Qualification Certificate.
- Matriculation/Date of Birth Certificate issued by the recognized Education Board. b.
- Health Certificate from the concerned Chief Medical Officer of the District.
- Domicile Certificate from the Competent Authority.
- Valid Relevant Category Certificate, if any applicable. e.
  - That if the candidate has availed loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, the appointee shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. The appointee shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

The appointment of the candidate shall further be subject to the following conditions:-

- The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee has no criminal record and is not facing any criminal proceedings in any court of
- ii. If on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee for appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- iii. The salary of the appointee shall not be drawn and disbursed to him, unless satisfactory report in respect of genuineness of qualification/date of birth/relevant category certificate is received from the concerned issuing authority.
- The appointment of the candidate shall be governed by the "New Pension Scheme" as per iv. SRO-400 of 2009 dated 24.12.2009.
- The appointee shall be on probation for a period of 02 years. V.
- The cadre/Department allocated by appointing authority/SSB shall not be changed under any vi. circumstances by any authority/Department.
- vii. The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he shall also be liable for criminal prosecution.
- The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, VIII. pending before any competent court of law.
