Ex post-facto sanction is hereby accorded to the reimbursement of medical expenses incurred by Mrs. Sabiya Rajab (Junior Engineer) R&B Division, Budgam on her treatment at Yashoda Hospital Secunderabad, Hyderabad in relaxation of rule 6-A of the J&K Civil Services (Medical Attendance-Cum-Allowance) Rules 1990, subject to the following conditions:-

- i. Reimbursement of charges shall be restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof shall be restricted to the extent of rates applicable to such items/procedures at AIIMS, New Delhi.
- ii. All relevant medical bills/vouchers shall be verified from relevant medical authority of the hospital wherefrom treatment has been taken.
- iii. Essentiality Certificate on Form 2 issued by the Hospital authorities is obtained ad kept on records.
- iv. Follows up(s), if any are regulated under rules.
- v. Reimbursement of travelling expenses for patient and one attendant shall be restricted to rates of travelling such journey by shortest possible route by the class of which she is entitled for journey on tour.
- vi. Certificate from the competent medical authority (Director Health services/Principal GMC/other) is obtained to certify that drugs and services charged are reasonable and to establish genuineness of the treatment availed in the said hospital.
