Government Order No: 329 -PW(R&B) of 2021 Dated: 24 /10 / 2021

On the recommendation of the J&K Services Selection Board and in continuation to Government order No. 328-PW(R&B) of 2021 dated 23.10.2021, sanction is hereby accorded to the appointment of Thirty Eight (38) selected candidates against the post of Class-IV in the Divisional Cadre Jammu/ Kashmir as per details forming annexure to this order in respective categories of nomenclature of the post as Indicated against each in the Pay Level of SL-1 (14800-47100) in the Public Works (R&B) Department.

The appointee(s) shall report to the office of the concerned Chief Engineers, PW (R&B) Department Jammu/ Kashmir within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

- Academic Qualification Certificate.
- ii) Date of Birth Certificate
- ill) Health certificate from the concerned Chief Medical Officer of the District.
- iv) Domicile Certificate from the competent Authority.
- No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

The appointment of the appointee(s) shall further be subject to the following conditions:-

I. If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee(s) for appointment as (Class-IV) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.

- The candidates shall furnish an undertaking in the shape of affidavit to the II. effect that the appointee(s) have no criminal records and also not facing any criminal proceedings in any Court of Law.
- The salary of the appointee(s) shall not be drawn and disbursed to them III. unless satisfactory report in respect of qualification /other certificates as well as final CID verification are received from the concerned authority.
- IV. All these appointments shall be made in terms of the Jammu and Kashmir Probationer (Condition of Service, pay and Allowances) and Fixation of Tenure Rule, 2020 notified vide S.O. 192 of 2020 dated 17.6.2020.
 - The cadres/Departments allocated by appointing authority/SSB shall not be ٧. changed under any circumstances by any authority/Department.
- The appointments shall be cancelled abinitio, if it is found that the candidate VI. is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
- VII. If the candidates fails to join within a period of twenty one (21) days from the date of issuance of order they shall forgo right to appointment which shall be shall deemed to have been cancelled abinitio without any further notice.
- VIII. All the appointment orders shall be issued subject to outcome of any petition/(s) pending in any competent court/Tribunal etc.
