The committee shall conduct the physical verification of the stores of corporation under overall supervision of Financial Controller of JKPCC and the concerned General Manager JKPCC and submit its recommendations within one month.

Terms of reference (ToR) of the committee shall be as follows:

- The committee shall verify stores received/issued and available in the respective stores/sites as per the books of the store.
- The committees shall recommend disposal of the stores clearly indicating serviceable and /or obsolete /un-serviceable store providing reasons thereof in each case.
- III. The book value, guiding price and reserved price, which will be required while disposing of the surplus goods, shall also be worked out by the committees. In case where it is not possible to work out the book value, the original purchase price of the goods in question may be utilized.
- The committee shall prepare a report of stores for disposal prepared in Form GFR-10.
- V. In case an item becomes un-serviceable due to negligence, fraud or mischief on the part of a Government servant handling the store, the same shall be brought forward for fixing of responsibility.
- After declaring the stores as surplus/obsolete or un-serviceable, it shall be disposed strictly in terms of Rule-218-221 of GFR-2017.
