Fixation of seniority of Mr. Bashir Ahmad Allai, Executive Engineer (Civil) of PW(R&B) Department.

Government Order No : 354 - PW(R&B) of 2021 Dated: 17 .11.2021

Whereas, vide Government Order No. 217 –PW(R&B) of 2011 dated:04.07.2011, the final seniority list of Executive Engineer (Civil) of PW(R&B) Department as it stood on 01.01.2006 was notified; and

Whereas, the recommendation of Mr. Bashir Ahmad Allai, among other Engineers was withheld by the JKPSC/DPC for want of vigilance clearance, Work, Conduct and Integrity certificate and APR's; and

Whereas, vide Government Order No. 31 –PW(R&B) of 2021 dated 22.01.2021, Mr. Bashir Ahmad Allai I/C Executive Engineers was regularized as Executive Engineer notionally w.e.f. 31.05.2003 and regular basis w.e.f. 23.11.2006 on the recommendation of PSC/DPC; and

Whereas, the seniority of Mr. Bashir Ahmad Allai, needs to be notified for processing his case for regularization as Superintending Engineer; and

Whereas, in this regard, the department issue a notice vide endorsement No. PW(R&B)/HRM/13/2011-III dated 05.04.2021 for inviting objections; and

Whereas, the department has received no objection therefore, the seniority position assigned to Mr. Bashir Ahmad Allai is now treated as final; and

Whereas, the seniority of Mr. Bashir Ahmad Allai, Executive Engineer figures at 73 i.e. below Mohammad Amin Bhat of the final seniority list of Executive Engineer (Civil) of PW(R&B) Department issued vide Government Order No. 217–PW(R&B) of 2011 dated:04.07.2011; and

Whereas, the JKPSC, vide Communication No. PSC/DPC/PWD-SE/23/2014 dated 06—08-2021 raised observation that the seniority of Mr. Bashir Ahmad Allai, Executive Engineer (Civil) should be fixed as per the decision of the minutes of the DPC meeting held under the under the Chairmanship of Shri. K. B. Jandial Hon'ble Member on 23-04-2014; and

Whereas, as per decision of the minutes of the above said meeting, the seniority of Mr. Bashir Ahmad Allai, Executive Engineer was to be re-fixed at seniority No. 61-A i.e. between Babu Hussain and Abdul Hamid of the final seniority list of Executive Engineer (Civil) of PW(R&B) Department issued vide Government Order No. 217-PW(R&B) of 2011 dated:04.07.2011.

Whereas, in this regard, the department again issued a notice vide endorsement No. PW(R&B)/HRM/13/2011-III dated 13-10-2021 for inviting objections; and Whereas, the department has received no objection therefore, the seniority position assigned to Mr. Bashir Ahmad Allai is now treated as final; and

Accordingly, the seniority of Mr. Bashir Ahmad Allai, Executive Engineer is fixed at 61-A between Babu Hussain and Abdul Hamid instead of 73 i.e. below Mohammad Amin Bhat of the final seniority list of Executive Engineer (Civil) of PW(R&B) Department issued vide Government Order No. 217-PW(R&B) of 2011 dated:04.07.2011.
