Terms of reference of the committee shall be as under:-

- a) The committee shall examine whether the change in technical evaluation methodology has been caused by forfeiting the sixty points on the basis of technical evaluation and making the technical evaluation merely a bench mark to cross rather than a quantitative factor to disqualify the bidder and whether the tender opening committee does away with the technical points given to the basic requirements without paying any attention to total cost of ownership.
- b) The committee shall examine whether the basic requirement of providing a four wheel drive machine was clearly and explicitly reflected in NIT and the tender opening

committee accepted a two wheel drive certificate instead of required four wheel drive certification. The committee shall also examine whether the tender opening committee received/ accepted the post dated ARAI 4WD certificate and thereby altering the whole tendering process otherwise the company should have been disqualified for financial bid after failing to provide the requisite certificate.

c) The committee shall examine, was it an unusual promptness in issuing letter of intent to L1 i.e M/S Case New Holland Construction Equipment Pvt. Ltd. As the report for valuation of price and other technical requirements passed through three different offices within a single-

within a single working day.

d) The committee shall examine the complete report of the ACB and can take up any other point of delinquency for their examination, as per their domain.

e) The Committee shall give its recommendation/suggestion on the case.

f) The committee shall ensure strict compliance to all rules, procedures/guidelines issued by Government from time to time while conducting the said enquiry.

g) The Committee shall be serviced by the office of Chief Engineer, MED, Kashmir.
