Whereas, the Chief Engineer, PMGSY (JKRRDA) Kashmir has forwarded the case of Ms. Sham-Sul-Nisa Draftsman (Civil) whose particulars are given below for accepting of three years Diploma acquired by her and also inclusion of her name in the relevant seniority list:-

Whereas, the case was examined in this department and diploma/ marks certificates of the above named official were forwarded to the concern Board vide this department's letter dated 19.01.2022 for verification/ authentication of genuineness of the diploma/marks certificates acquired by the official. In response, the said Institution vide No. 1157/CERT dated 13.09.2022 has verified the genuineness of Diploma acquired by the official.

Whereas, the above named Draftsman (Civil) has also produced undertaking in the shape of Affidavit affirming therein that if on verification, her diploma certificate is found fraud/fake/forged at any time during service, her diploma shall be deemed to have been cancelled ab-initio.

Whereas, on examining the case, it has been observed that there is a case to accept the Diploma certificates acquired by the above named official and include her name at appropriate place in the relevant seniority list of Diploma holders Draftsman(Civil) as and when the same is notified afresh by the Administrative Department.

Whereas, the case was further examined in the department and a notice was issued vide No. PWD-HRM1/127/2022- 05 dated 04.11.2022 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer PMGSY (JKRRDA) Kashmir vide letter No. CE/PMGSY/K/ Etab/9942 dated 23.12.2022 has intimated that no objection regarding the matter have been received by this organization till date.

Now therefore, Ms. Sham-Sul-Nisa, Draftsman (Civil) shall henceforth be treated as Diploma holder Draftsman (Civil) and subsequently her name shall be included at appropriate place in the relevant seniority list of Diploma holders Draftsman (Civil) as and when the same is notified afresh by the Administrative Department.
