Subject: Settlement of suspension period.

Whereas, Shri Mohammad Shafi Bhat S/o Ghulam Mohammad Bhat R/o Kursoo Rajbagh Srinagar, Works Supervisor (now retired) of R&B Construction Division No. 2nd Srinagar was placed under suspension vide Chief Engineer's office Order No. CE-PWD(R&B)K-261/(ESTAB) of 2013 dated 07.12.2013; and

Whereas, Shri Nazir Ahmad Kunjwal, Junior Engineer was placed under suspension vide Government order No. 240-PW(R&B) of 2019 dated 14.5.2019; and

Whereas, the cases of the aforesaid officials were placed before the Departmental Review Committee on 15.01.2021 & 08.6.2021 for re-viewing their suspension and the Review Committee recommended to re-instate both the officials; and

Whereas, Shri Mohammad Shafi Bhat, Works Supervisor (Retired) and Shri Nazir Ahmad Kujwal, Jr. Engineer got re-instated vide Government order No. 211-PW(R&B) of 2021 dated 24.6.2021 and Government order No. 93-PW(R&B) of 2021 dated 24.02.2021 respectively with the condition that their period of suspension shall be decided separately; and

Whereas, the Departmental Review Committee was held under the Chairmanship of the Principal Secretary to the Government, Public Works (R&B) Department on 15.9.2021 to review the settlement of suspension period of Mr. Mohammad Shafi Bhat (Works Supervisor) R&B Construction Division 2nd (Retied) & Nazir Ahmad Kujwal, Junior Engineer, Left River, Circular Road Division (R&B) Srinagar; and

Whereas, the Committee recommended to take following action in the cases in the first instance:-

- In the case of Mohammad Shafi Bhat, Works Supervisor (Retired) a report from Prosecution Wing of the SSP Srinagar, shall be obtained to the effect, as whether the Prosecution/Bank authorities have filed the appeal against the said judgment of the trial court before the next higher Forum.
- 2. In the case of Mr. Nazir Ahmad Kujwal, Junior Engineer, the vigilance status of the Engineer shall be obtained from the General Administration Department (Vigilance) to ascertain whether the closure report of the RDA has been accepted by the GAD/ACB.

Whereas, subsequently, the matter was taken up with the concerned authority/

agency for ascertaining the requisite reports in light of the observation of the Committee; and

Whereas, in the case of Mr Mohammad Shafi Bhat, Works Supervisor(Retired), the Sr. Superintendent of Police, District Srinagar vide his communication No. Lgl/Court-Acquit/2021/20134 dated 13.11.2021 intimated that perusal of said judgment, reveals that it is case FIR No. 36/2002 instead of 56/2002 of P/S Kothibagh, Srinagar and the matter had been taken up with the Dy. Director Prosecution Srinagar and SHO P/S Kothibagh, who have intimated that no appeal has been filed in the instant case and further details can be had from Law Department in the matter; and

Whereas, in the case of Mr Nazir Ahmad Kujwal, Junior Engineer, the Anti Corruption Bureau, J&K and as per the available records with GAD (Vigilance) endorsed vide Form No. 34128 dated 24.9.2021, nothing adverse has been reported against the engineer; and

Whereas, the Departmental Review Committee meeting was again held on 01.12.2021 at 03:00 PM under the Chairmanship of the Principal Secretary to the Government, Public Works (R&B) Department to review settlement of the suspension period of Mr. Mohammad Shafi Bhat S/o Ghulam Mohd Bhat R/o Kursoo, Rajbagh, Works Supervisor (Retired) & Mr. Nazir Ahmad Kujwal S/o Gh. Qadir, Junior Engineer; and

Whereas, as per minutes of the meeting issued vide No. PWD-NGAZOCIV/24/2021-05 dated 08.12.2021, the committee recommended that the period of suspension of Mohammad Shafi Bhat 5/o Ghulam Mohd Bhat R/o Kursoo, Rajbagh, Works Supervisor (Retired) w.e.f. 07.12.2013 to 29.4.2019 & Mr. Nazir Ahmad Kujwal 5/o Gh. Qadir, Junior Engineer w.e.f. 14.5.2019 to 24.2.2021 to be treated as on duty.

Now, therefore, sanction is hereby accorded to the treatment of period of suspension of Mr. Mohammad Shafi Bhat 5/o Ghulam Mohd Bhat R/o Kursoo, Rajbagh, Works Supervisor (Retired) w.e.f. 07.12.2013 to 29.4.2019 & Mr. Nazir Ahmad Kujwal 5/o Gh. Qadir, Junior Engineer w.e.f.14.5.2019 to 24.2.2021 as on duty.
