Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

 a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and

 at its discretion terminate the probation of a probationer and discharge him from the service.

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by the below mentioned Junior Assistants is hereby accepted and are discharged from the Government service w.e.f. the dates as indicated against each on their own request:
