Subject: Acceptance of resignation of Junior Assistant.

Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. JKSSB-PLAN/25/2022-03 dated: 03/03/2023, among others, Shri Irfan Rashid Sheikh was appointed as Junior Assistant vide Government Order 208-PW(R&B) of 2023 dated: 26/03/2023 and his services were placed at the disposal of Chief Engineer Mechanical & Hospitals Engineering Department, Kashmir.

Whereas, subsequent to his appointment/joining, the Chief Engineer, Mechanical & Hospitals Engineering Department, Kashmir vide his communication No. CE/M&HED/K/Adm/2683 dated: 19/09/2023 has informed that Shri Irfan Rashid Sheikh, Junior Assistant working in MHCHD Srinagar has tendered his resignation from the post of Junior Assistant w.e.f 01/08/2023 through the medium of an application dated 05.08.2023; and

Whereas, the Chief Engineer, Mechanical & Hospitals Engineering Department, Kashmir forwarded his request to the Public Works(R&B) Department for acceptance of his resignation as the said candidate has been selected as Junior Stenographer vide Government Order No. 891-JK(GAD) 2023 dated: 25/07/2023.

Whereas, the matter has been examined/ considered with reference to the rules governing the subject and it has been observed that the concerned employee is still on probation and has not qualified the prescribed probation period of service; and

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

**"At any time before the expiry of prescribed period of probation the appointing authority may:**

- a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and**
- b. at its discretion terminate the probation of a probationer and discharge him from the service.**

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Shri Irfan Rashid Sheikh, Junior Assistant, MHCHD Srinagar is hereby accepted and is discharged from the Government service w.e.f. 01.08.2023 on his own request.
