**Subject: Re-organization/Restructuring of Public Works (R&B) Department-
sanction of DDO Powers thereof.**

Sanction is hereby accorded to the delegation of Drawing & Disbursing Powers in favour of the following officer of Public Works (R&B) Department for operating upon the treasury for operation of funds placed at their disposal under Major Heads: 2059-Public Works, 3054-Roads & Bridges, 2071-P&ORB, 2055-Police, 5054-COORB, 4059-COOPW, 8009-GP Fund, 8011-SLI, 8443-Civil Deposits & remittances thereof. The DDO concerned shall also operate funds placed at their disposal on BEAMS of works of other departments placed by the competent authority under relevant heads of account:

01	Superintending Engineer, DIQC	Civil Secretariat Treasury Srinagar /Jammu

The DDO Powers are subject to the fulfillment of following conditions.

1. The DDO shall operate on the treasury to the extent of funds placed at his disposal by the Competent Authority.
2. That all the codal formalities are to be fulfilled while incurring the expenditure.
3. That no excess over allotment/irregular expenditure is made by the DDO.
4. That the concerned DDO shall ensure submission of the Accounts to the different quarters in time and maintain record as prescribed in General Financial Rules, 2017/Manuals.
5. That the DDO shall submit the monthly/quarterly Receipt/Expenditure statements to the Administrative Department through their controlling officer.
6. DDO shall also obtain AG's Code from the Accountant General, J&K.
7. That the DDO powers are temporary till the arrangement for posting of Accounts Officer in the office of Chief Engineer DIQC by Finance Department.
