On the recommendations of the J&K Services Selection Board and in continuation of Government Order No. 412-PW(R&B) of 2022 dated 23.11.2022, sanction is hereby accorded to the temporary appointment of Wasim Ahmad Katariya S/o Mohammad Zaman Katariya (SL.S.No. 8, ST-130, D.V. S.No. 201-KMR, Registration No. 8638, Roll No. 1057607) against the post of Junior Engineer (Civil), in the Pay Level-6 (35400-112400) under ST Category in the Public Works (R&B) Department.

The candidate shall report to the office of the Chief Engineer, Kashmir within a period of twenty one (21) days from the date of issuance of this order. In case the candidate fails to join within the stipulated time period, his appointment shall be deemed to have been cancelled ab-initio

allowed to join after production of the following without any notice. The appointee shall be certificates/documents (in original) to be verified separately:-

- 1. Educational/Technical Qualification issued by the recognized Institute/University valid for employment
- 2. Matriculation/Date of Birth Certificate from recognized education Board.
- 3. Domicile certificate issued by the competent authority.
- 4. Health Certificate from the concerned District Chief Medical Officer.
- 5. Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any self employment scheme has been availed by the
- 6. Valid relevant category certificate issued by the competent authority, if any applicable.

The appointment of the above candidate shall further be subject to the following conditions:-

- 1. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any court of
- 2. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of his qualification/degree certificate/Date of birth/relevant category certificate is received from the concerned issuing authority.



- 3. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- 4. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by the appointee in the selection list prepared by the Services Selection Board.
- 5. The appointee shall be on probation for a period of two (02) years as per Rule 20 of J&K Civil Services (CCA) Rules, 1956.
- 6. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before any competent court of law.
